When the name of Mr. Christiancy was read in calling the roll of the Senate this afternoon, Mr. Ferry, President pro tem said with a slight twinkle: "I desire to state that my colleague is paired"-a remark which created general laughter all over the Chamber.

Late dispatches from St. Louis announce that Constantine Maguire, the late collector of internal revenue, who was to be put on trial for complicity in the whisky frauds next after Mc-Kee, had pleaded guilty to all the counts in the indictment cgainst him except that charging him with conspiracy, the prosecution consenting to its withdrawal. The five counts to which he thus plead guilty charge him with neglect or dereliction of duty in not reporting to his superior officer, and with numerous other irregularities of detail. Mr. Voorhees, who was the leading counsel for Maguire, as he had been for McKee, after announcing the charge of plea continued with some remarks which may be regarded as an appeal for a mitigation of sentence. He stated that when Maguire took charge of the office of collector he was unused to its Juties, surrounded by difficulties unforeseen, and influences more powerful than himself, and that these difficulties and influences in a great degree caused his neglect of duty. He was innocent of intentional misconduct, and feels innocent yet, except so far as he was controlled by the influences brought to bear upon. ## · McKee's Sontonce.

There are rumors in St. Louis that an arrangement is being made between District Attorney Dyer and Mr. McKee's counsel, by which the latter is to escape the penalty of im-prisonment and to be let off on the payment of a heavy fine. The rumor goes so far as to say that Judge Dil-lon and Treat are ready to lend themselves to this arrangement, if they can be convinced that it is not contrary to law. We do not give the lightest credence to such reports. The only possible grounds for mak-ing an exception in McKee's favor are his wealth and his former respectability. But, rightly viewed these

only aggravate his offense, instead of mitigating it. He was already rich when he went into this conspiracy, and was tempted neither by necessity or ambition. His respectability makes his crime greater because it adds hypocrisy to it. A leading church member, a veteran editor, he certainly fully understood the nature of the crime he was committing, both in its moral and legal aspect, and yet he committed it, coolly, deliberately, with no incentive except that of avarice and greed. He is as much guiltier than the lower thieves of the ring-Joyce, Megrue, McDonald, ct id omne genus-as his perceptions of right and duty were clearer, his professions of morality higher, and his temptation less. To punish these smaller scoundrels with lengthy imprisonment and to let off a "respectable" scoundrel like McKee with a fine which he can easily pay from the produces of his theft would be mockery of justice.
