



No little excitement was caused nere yesterday by the attempted es-



Mr. O'Hara Fells Why He is Giad Defeat



The final steps in the settlement of the estate of the late Burton Jarvis, of Buchanan, have been taken, and a long litigation over a valuable property is now practically at an end

The account of Administrator Frank Jarvis, was allowed a few days ago by Probate Judge Ellsworth at St. Joseph and a final order of distribution was made.

The estate of Burton Jarvis, who died without a family was appraised at a little over \$50,000.

About \$12,000 was disposed of in small bequests. The remainder of the estate amounting to about \$30,after the expenses of administration, the inheritance tax and the costs of litigration have been paid, is what is now being distributed under order of the court.






