

Attorney White, for the state, began his argument, at the conclusion of Judge VanRiper's address. He stated that the jury was impartial in all respects, and that so far as he knew there had never been a better jury in this county.

For the purpose of refuting the statements in the Brunke, Moreland and Bruce affidavits, White introduced two from R S. Goodall and Fred Geisel, the jurymen. Goodall told all of the conversation which Geisler had with the makers of VanRiper's afindavits. Geisler, according to Goodall, when the men asserted that it was a shame to convict a man for guarding his home, replied that had they been with the jury and had heard all the evidence in the case that they would have made the same verdict. Geisler's affidavit was to the same effect, and both the jurors denied the statement as to the talk in the jury room.






