South Haven Games No Guide, Reports Niles

Buchanan Defeats Berrien Shamrocks 25 to 0

Don't place too much confidence in comparative scores by Niles and Buchanan high school grid teams against South Haven in forecasting the results of the clash of the locals with Niles next Friday night, according to reliable information secured by Buchanan spies sleuthing in the camp of the enemy.

It is true that South Haven defeated Niles in the latter's first conference game last Friday 25 to 7, while the locals lost on the preceding Friday only 14-0 and might very well have chalked up a lone marker, same as Niles, if Lady Luck had so decreed. But it appears that Niles had its two star backfield men on the sidelines that night, Quarterback Bill Cashbaugh being out with a twisted shoulder and Walt Wilson, the Vikings man ground game, out with an injured ankle. Both these men will be back in the line-up Friday night, with consequent strengthening of the enemy offensive. The two men had been injured in a game with South Bend Central.

However Buchanan's green team is gaining in ability and the contest should be a battle worth witnessing. It will start at the Niles field at 8 p. m. Friday, Oct. 13.

Backs Win Over Berrien Springs (Doris Fuller) Friday, Oct. 6, at Berrien Springs Buchanan beat the Shamrocks, 25-0.

In the first quarter Buchanan showed great strength and good spirit. The first touchdown was made by Bob Letcher on a pass from the ten-yard line in the second quarter. The score at the end of the half was 6-0. Lowell Dockey's kicking was above par at this game.

"Mighty" Bob Letcher scored for Buchanan by a 60-yard run early in the third quarter. Again Letcher got off on a 50-yard run putting the Bucks on the five-yard line. A line-back was made, and another score for Buchanan, making the score 18-0 at the end of the third quarter. In the fourth quarter Eugene Wesner intercepted a pass and made a touchdown, and a goal kick was made by J. B. Anderson. The score at the end of the game was Buchanan 25, Berrien Springs 0.

Electors to Pass on Proposals to Waive 15-Mill Tax Limit and to Levy Special 5-Mill Tax for 5-Year Period

School Board Points to Steady Increase of Pupils; Present Necessity of Leasing Outside Room, and Advanced Age of Dewey Avenue School Building

The question of whether or not the Buchanan community should at this time authorize the method proposed by the school board for the creation of a special fund for the ultimate construction of a new school building will be submitted to the qualified voters at the special election, to be held tomorrow (Friday), Oct. 13, in Room 4 of the high school building, between the hours of 2 p. m. and 8 p. m.

Two ballots will be submitted to the voters. One contains the proposal to waive the 15-mill levy limitation, and is stated on the ballot as follows: "Shall the limitation on the total amount of taxes which may be assessed against property of School District Fractional No. 1 of Buchanan City and

part of Niles and Buchanan townships, Berrien County, and State of Michigan, for all purposes except taxes levied for the payment of interest and principal on obligations incurred prior to Dec. 8, 1932, be increased for a period of five years, from 1944 to 1948, both inclusive to 2% of the assessed valuation of all property in the district, as provided in Sec. 21, Art. X, of the Constitution of Michigan?"

The second proposal, which depends on passage of the first, is designed to define the amount of the special tax increase, in the amount of the special tax increase, in the event that the waiving of the 15-mill limitation is endorsed. It is stated on the ballot as follows: "Shall school district fractional No. 1 of Buchanan City and part of Niles and Buchanan Townships, County of Berrien and State of Michigan, levy five mills to create a sinking fund for the purpose of building buildings or additions, and equipment for a period of five years?"

The proposal to waive the 15-mill limitation will require a majority of two-thirds of the vote cast to carry. It should be clearly understood that in the case of both proposals, the majority requirements relate only to votes actually cast and not to the total potential vote.

The proposal to levy a special five-mill tax will require a majority of over 50% of the vote cast at the election.

WHO IS ELIGIBLE? The qualifications for voting on the two proposals are not the same. They are as follows: FOR VOTING TO INCREASE THE MILL LIMIT—Must be a U. S. citizen, 21 years of age, resident of the state six months and of school district 20 days immediately prior to date of election.

FOR VOTING FOR SPECIAL 5-MILL LEVY—Must be U. S. citizen, 21 years of age, resident of school district three months, owner of property which is assessed for school taxes in the election.

All voters must have been registered as qualified school electors.

EXPENSE OF BOND ISSUES According to a letter received by Supt. H. C. Stark from the Harris Trust & Savings Co. of Chicago on Aug. 29 the total interest paid on the bond issue which financed the present high school building up from July 1, 1922, to July 1, 1944, was \$182,646.50 as compared with the \$200,000 face value of the bonds. This with five years still to go, suggesting that before the bonds are entirely paid for, the interest payments may equal or exceed the face of the bonds.

It is of course true that the construction of the high school building in 1922 was financed with 5 1/2% bonds, and that money can be borrowed much cheaper at the present time. However, the price of money five years from now is not predictable, and the interest costs will at any rate be large.

HOW MUCH MONEY WILL BE NEEDED? Since the two proposals look toward the creation of a building fund for future construction, it is not possible to forecast accurately at this time the size of structure that will be needed when the time comes to build.

It should be clearly understood that a vote permitting the waiving of the 15-mill limitation will not give the school board unlimited power to tax in excess of such limitation. Any levy in excess of that limit must be approved by the voters, which is the reason for the additional balloting on the five-mill special tax levy.

Based on a valuation of \$4,500,000 for the district this five-mill levy will build up a special building fund of \$22,000 per year, or \$510,000 in the five-year period authorized on the ballot. No more can be secured by the school board without additional authorization by the school electors.

It is the belief of the board that a postwar building program will very likely be inaugurated, by which this \$110,000 may be matched by federal or state funds.

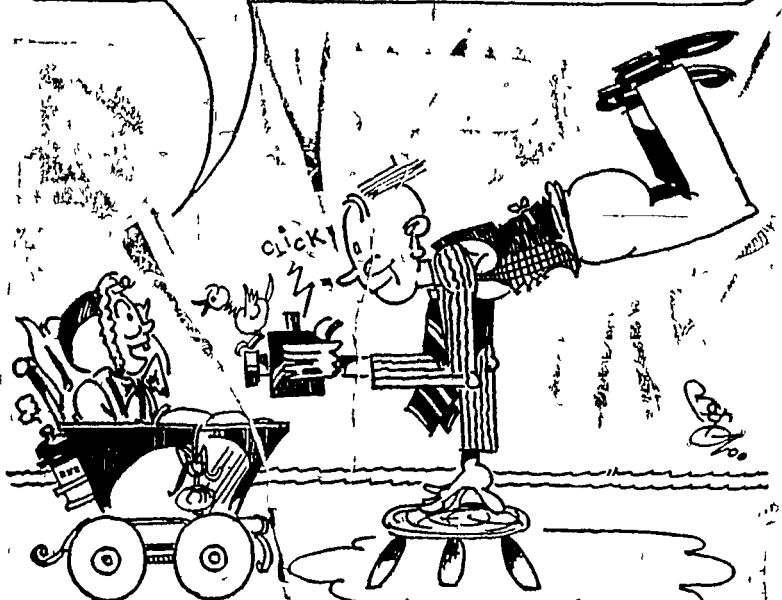

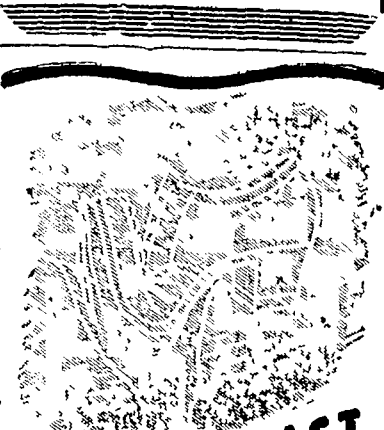

IS A NEW BUILDING NEEDED?
It is a fair question to ask whether a new building will be needed five or more years from now, after the boom of war work has subsided and a more or less normal element dwells here by high wages may have gone elsewhere.
A survey of the rate of growth of school population for the past 22 years will cast some light on this question. In 1922, the date of the last school building construction, there was an average enrollment of 645 in the schools. At the end of the first month of the 1944-5 school year there was a total enrollment of 1198 in the schools. It would seem that to compare the total enrollment at this time to the average enrollment in other years is certainly being fair enough to the doubters at least. This represents a growth of 85.7% in 22 years. Dividing that period of time into two-year periods, the rate of biennial growth each year as measured from the original figure of 1922 was as follows: 1922-24, 8.7%; 1924-26, 22.85%; 1926-28, 38.3%; 1928-30, 48.7%; 1930-32, 50%; 1932-34, 62.7%; 1934-36, 61.1%; 1936-38, 60%; 1938-40, 61.6%; 1940-42, 66%; 1942-44, 87.7%.
It will be noted that 61.1% of this increase antedated the World War II period. While there has been an increase of 24.1% since 1940, the rate was surpassed during the four-year peace period from 1926 to 1930 when the increase was 26%.
However the weightiest reason for the measure is the need for an early retirement of the 6-room Dewey Avenue school building,
The intention of this election is, very frankly, to see that no such record is made. The proposed building fund is to be built up with the purpose of retiring that structure before many more years pass. According to all traditions, this school antedates any business house along Front street by several years.

Oliver Wendell Holmes wrote in his "One Hoss Shay"—we quote from memory—
"Few of us be that linger here To wake on the morn of our hundredth year Without both looking and feeling queer."
The old Dewey Avenue school is perilously near that age. Perhaps, like the one-hoss shay, it will celebrate its hundredth birthday by falling flat in a rubber heap, all parts giving out at once. Let's hope it will be empty that morning. Ten or twelve years slip away fast, and that lapse of time will bring the old structure to the status of a centenarian.
Although there are no business records of the Buchanan school district in existence beyond 1900, it is known on adequate evidence that the building now known as the Dewey Avenue school now approaches 90 years of age. Ensign's History of Berrien and Van Buren Counties, published in 1879, has the following to say:
"1843 a frame schoolhouse 20x40 feet, was erected on Lot 23 of the John Hamilton plat at a cost of \$170 (This building is now the home of Mrs. Henry Long at 305 Main street.) The district at that time contained 50 children of school age.
"1854 the district was reorganized under the law into a union school district, and erected a two-story brick edifice 30x40 feet in size, at a cost of about \$4,800. At this time there were 160 children enrolled in the district."
According to a letter written to the writer by the late Ida Weaver Emerson, the school opened in 1856 with George M. Dewey, grandfather of Thomas E. Dewey, as its first principal. She stated that George M. Dewey held the position only one year. In old newspaper files now at the Niles Public Library, there is evidence that George M. Dewey went to Niles in 1857 and soon after became the editor of the first Republican newspaper in this section the Niles Enquirer. All of the above places the erection of the Dewey Avenue building somewhere between 1854 and 1856, making the building somewhere between 88 and 90 years old at the present time. Like the people of Buchanan, this building gets a year older every year. In a little over ten more years it will be 100 years old. If it is used as a school building that long it will undoubtedly constitute something of a record in Michigan school history—and not one to boast of.

Europe a number of years ago. I don't know, but I have found these French the nicest race I've met yet. I remember some of the veterans from the other war telling how wonderful these people were and from my opinion they haven't changed. There are several of them who can speak English and from them, I've learned that we rate at the top with this country also. I admire their ways of dressing and etiquette. It seems that shaking hands is the French way of greeting even though the persons do not know each other. I remember especially the first mademoiselles I met. There were several of them and I wasn't aware of them because if they were like most girls they wouldn't stop to speak. Every one of these girls stopped to shake hands with me and of course I was somewhat startled. If they could speak English it would be much easier but it always makes you smile when you see them smile at you with that bright twinkle in their eyes. Every Frenchman seems to have that.

As for the country itself, some parts aren't much different than the midwestern states. There are numerous fields of wheat and oats and several apple orchards. Very few of the farmers have modern machinery, which, I imagine, is because of the war. That doesn't stop them however. I've watched several of the old men cut grain with a cradle and scythe and they are no amateurs. The women and girls walk along behind and tie it up in bundles with sheaves of grain and they are skilled at the trade too. The apples are used mostly for cider. I don't like it nearly so well as that made by our apples in Michigan. Wine and cognac are the French favorites too. The soldiers who like to boast of their capacity for drinks tell me that cognac is a little strong and it must be from the way they act. I heard once that it was a mixture of airplane gasoline and castor oil and it certainly reacts as such. I hope you are hearing from the boys often. 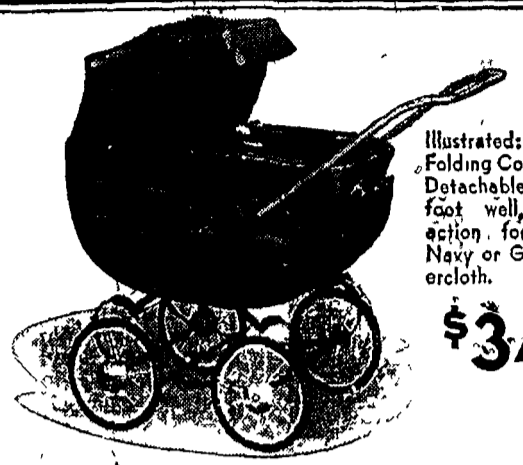

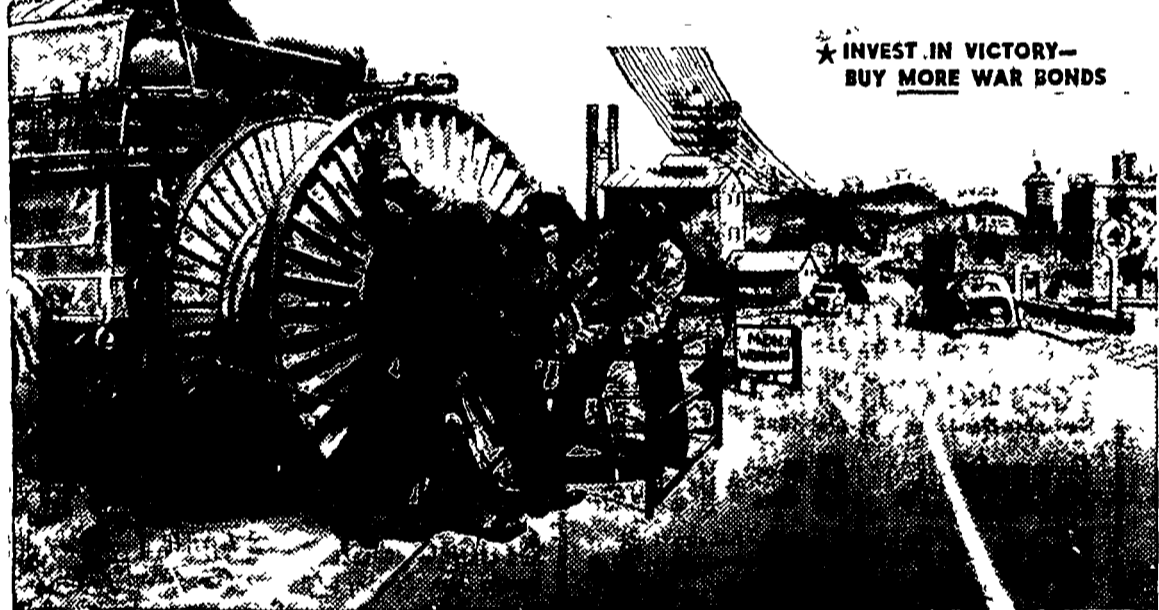
