Small Cyclone Hits Bakertown

Fruit Stand Thrown Over Car Top On M-60 At Sebasty Farm

What had the earmarks of a small cyclone swept diagonally through the farming country south of Dayton and through Bakertown about 5 p. m. Tuesday, acquiring considerable violence on the ground in some places.

Most spectacular, though not costly, damage was done at the Ralph Sebasty farm where the farm fruit stand on M-60 was lifted into the air and tossed over a car on the highway.

Several small buildings were blown down on the Claude Sheldon farm. A tree on the Louis Sebasty farm near the Mt. Zion stone road was blown across the road. Trees, haystacks and straw stacks were blown down or scattered.

Ralph Sebasty saw the storm pass along the route of M-60 but could not see his house. He stated that there was a cloud of dust and debris, including limbs of trees traveling through the air. It is reported that this cloud traveled toward Buchanan.

Elward Ramsey Dies Suddenly

Elward Ramsey, 67, died suddenly at 2 p. m. Wednesday at his home at 206 Main street, four hours after he was stricken with a heart attack, the first illness of his life.

He was born in Churubusco, Ind. on July 20, 1874, the oldest of 18 children, of whom 12 sisters and brothers still survive. He is also survived by four children: Blanche Ferris, Chicago, Ill.; Ethel Huffman of Cleveland, O.; David Ramsey of South Bend; Helen Bruner of Columbia City, Ind. He had lived in Buchanan or vicinity 13 years. Funeral arrangements had not been completed yesterday.

Tales of An Old Town An Attempt to Reproduce a Cross Section of The American Scene, As Witnessed Here Through the Past Century

Cleanings From the News of The Record's First Dayton Correspondent

Somewhere in Bay City, Mich. there is an old scrapbook which the writer hopes is in the hands of some one who will value it.

In it were treasured the mementoes, the memorial record of one, S. D. Hawthorne, who was perhaps the Record's first Dayton correspondent. In it are the clippings of his letters to the Record, filled with the news of Dayton plus goodnatured joshes about things there. Hawthorne was a Dayton station agent and telegrapher for the Michigan Central railway. He died in Bay City on Aug. 4, 1941, at the age of 86. We wonder how the Daytonites took Mr. Hawthorne's goodnatured joshings. They had no malice in them, but tender-minded readers can read most anything into humorous reference to themselves or affairs with which they are connected.

Hawthorne was a Methodist and religious-minded and once in a while he wrote in no humorous vein about Dayton's title to be called "the toughest town in Berrien county." He was young then—that was his second post, after his initial Michigan Central post at Daily, Mich. After less than two years he left Dayton because of the "ague swamp" just north of the old depot. It seems that Dayton was noted for ague as well as for sin in those days. The "shakes" racked the residents all summer through. The immediate cause of his leaving was the fact that his baby boy, born at Daily, was so severely afflicted with the ague.

Hawthorne evidently had an underlying flair for the printed word and some time to indulge in it between trains, so he took up corresponding for the Record, signing himself "The Duke." The first correspondence of his that we found in the files of 1876 had this as its opening item: "Mr. and Mrs. Sanders celebrated the fifth anniversary of their matrimonial junction on Monday, Nov. 29."

The use of the word "junction" was doubtless due to Mr. Hawthorne's habit of thinking in railroad terminology. A few weeks later he noted that "Mr. Sanders' little boy is ill this week."

Mr. Hawthorne's puritanic slant was in evidence, however, when he inadvertently to the subjects of drinking and dancing. A Methodist of that day could hardly condone either, so we find him referring to the Dayton dances, noted in this series last week as "the infestation of hoppers which struck this town Friday night."

Hell was about to break loose in Dayton, he stated one week, in noting that Bill Hardy's saloon was about to reopen. "Our first caller," wrote the late Hawthorne to Fred Richter while the latter was collecting information for this series a few months back, "after we got settled in the depot (the old depot was part dwelling, you know) was Aunt Currier, a relative of Bill Egbert's. She said she came to see if we were Christians. She had been praying that the next station agent sent there would be a Christian. We tried to live up to her desire."

Aunt Currier was an optimistic soul, it seems, in anticipating that a combination of railroad man, station agent and Dayton resident would be religious, but her prayers were evidently not without influence. There was probably a shortage of religion, in those days both in Dayton and in the railroad business.

But when Hawthorne's aversions were not the topic, he jotted cheerful, friendly paragraphs with a touch of humor here and there. On Jan. 4, 1877, he noted: "A few of the young aristocracy took a trip to 'The Hill' Monday night to see Uncle Tom played. Since they were late they had the pleasure of standing up the entire evening, consequently voting the trip a failure."

On Jan. 25 he noted that Mr. Sanders' little boy was sick again, this time with some kind of a fever. The teacher, a Mr. Fancher, was also sick and had to close the school. There seems little logic in this case for a small boy being sick while school was closed.

The principal amusement at Dayton that week was pike fishing on the lake. There were quite a number of fishing shanties on the ice. The Methodists were buying a new organ for the church and weekly mite societies were being held at the Hawthorne home to help pay for it. On Feb. 8, 1877, Hawthorne wrote rather caustically: "If we had another dancing club in Dayton everybody would be happy. There are only three in town." Meanwhile he was posting for the revival meetings at the church.

Mr. Marsh and his wife, the latter a niece of D. L. Boardman, are at present guests at the Boardman home. Marsh has spent many years in the American foreign diplomatic service. He was born and reared in the Mt. Tabor district north of Buchanan. His presentation of the films and accompanying talk should be extremely interesting, as he has been in close relations with conditions in Japanese-occupied countries for several years. The pictures will be presented in the high school auditorium. The public is cordially invited.

The program will open with an introductory talk by Mayor R. G. VanDeusen. John Elbers will talk on Civic Activities. Rev. Charles Hahn will talk on religious activities. Supt. H. C. Stark will talk on the schools. Two other talks will be made on Buchanan industry and Buchanan history by speakers not yet selected.

Mr. Boyden, director of special programs at station WSBT, is in charge of arrangements. The speakers will not go to the studio but will instead have their talks recorded by Boyden at the American Legion Hall at 2 p. m. Monday. The intervals between the three minute talks will be filled with transcribed music.

Post Office Sells First Duck Stamp

Sportsmen who expect to enjoy the duck hunting season might save themselves some inconvenience by buying their "duck stamps" now, instead of waiting until a day or two before the season opens and then find that the supply is exhausted, as it was last year. The federal law now requires that anyone hunting ducks in season carry a validated (signed) migratory bird stamp, selling for \$1. The funds from the sale of the stamps goes to the establishment of protective areas for breeding, feeding and resting of the migratory birds. The stamps have been on sale at the Buchanan post office since July 1, but first sale was made Monday, Sept. 8.

Kalamazoo Firm Low Bidder on P. O. Plantings

Bids for the landscaping of the local post office grounds were opened at 9 a. m. yesterday by Postmaster A. G. Haslett, with offers by three nurseries in hand. The low bid was from the Prudential Nursery Company of Kalamazoo, which bid \$530. Other bidders were M. H. Hunsiker & Son of Niles and Chesterton Nurseries, Inc., Chesterton, Ind.

On the basis of offers Haslett recommended the acceptance of the bid of the Kalamazoo firm, which was \$90 below the next lowest offer. All bids were then forwarded to the offices of the Public Buildings Administration at Washington, D. C., where the final decision is made.

Contracts call for the completion of the landscaping by Nov. 1, 1941. All evergreens are to be planted during the "most favorable period," from Sept. 15 to Oct. 1. All deciduous trees must be planted within the "most favorable period, from Oct. 15 to Nov. 1. The plantings include about 425 privet hedge plants in a double row staggered at 18 inch intervals in the rows, along the east and north lines of the grounds. Other plantings include groups of Japanese yew and hawthorne in corners of the grounds and of the buildings, and of sugar maples in the rear.

Trash Dumpers And Pranksters Raising Havoc

Hopkins Shack Removed; City To Make Dirt Fill at Park Approach

A move has been initiated by the park board, co-operating with city authorities to post the eastern end of Athletic Park to prohibit the trash dumping that is now disfiguring the park area, and to warn against the repetition of the acts of vandalism that have been committed against park property during the summer.

Latest of the series was the tearing off of the front of the switch box in which the switches for turning on and off the lights for the gridiron and softball are enclosed. Some time during the week-end an unknown party jerked the door and several boards off the front of this enclosure, and took the lock by which it was supposed to be secured.

The small tool house under one of the softball bleachers was broken into three times during the past summer and part of the tools and recreation equipment stolen. Two of the large lights have been shot out, and the metal cap on top of the flag pole donated by the I. & M. has been riddled with shot. Some one also burned off the rope by which the flag was to be raised and lowered. Other minor depredations too numerous to mention have been committed throughout the summer.

Chief in the disfigurements has been the dumping of trash to the south of the park pumping station. Parties engaged in stripping cars have apparently hauled their cars to this place, turn them up and left the unwanted parts strung over the ground.

There is not much use to complain of lack of appreciation of the park, and of its purpose and possibilities, on the part of those contributing to its disfigurement. It would very likely be more to the point to say that very likely nothing will be done in the prosecutions of past depredations if they cease, but if they continue it will be necessary to take means, to secure information covering the identity of all of those implicated. Information already in the possession of the board indicates that such identification will not be hard to make.

Considerable work has been done in the improvement of the park this summer, almost entirely without extra cost to the city. The improvements include the removal of the logs of the lumber and debris piles left on the site of the Hopkins sawmill, the removal of the small shack in the extreme southeast corner of the park, where Hopkins had lived, and the start of preparations for making all of this area a slightly approach, through planting grass. Before this is done from 200 to 300 yards of dirt are needed to fill the hole where the sawmill stood, and even up the slope from the creek to the level of the tennis courts. The city street department has already begun hauling dirt, from street excavations. By this means the city will accomplish without material extra expense work that would cost from \$200 to \$300 if paid for at regular prices.

THE CHILDREN I KNEW

The other day when I walked across Central Park, I paused to watch the happy children playing unafraid, and I thought of the children I had known in lands across the sea.

There was a little girl in a garden in Norway. She picked the first snow-flowers for me. She spoke no English, but when I said the German word "Schneeglockchen," it was close enough to the Norwegian to strike her fancy and she ran gaily from one object to another teaching me their names in her tongue and getting me to tell her what I called them in the strange gibberish I spoke. I wonder what has happened to Ingeborg now in her quiet garden under the hill! Are the strange words she is learning names for friendly things or are they the commands of a conqueror?

Then in Paris, there were Miki and Nini. Miki's starved little body proclaimed him a baby of the last war. Did he go out to fight for the France he loved? At seven he delighted in telling me in exquisite rippling tones of the glorious history of his beloved France. And his sister, studying German because one must always know the language of the enemy. Does she still read "Westerns" at every spare moment? She explained, "Mais, Mademoiselle, they are so free. When they fight, they fight so openly and they are so kind always. Do you know many cowboys?" Where are Miki and Nini now?

And Andrew, the little boy who, in a quiet home in Connecticut, looked at me so solemnly and said he was very lucky. He had two countries, America and Poland, and when he grew up he was going to see his "borri" country. He did—and the last we heard he was in a concentration camp in German-occupied Poland. What fate has befallen him?

Under what dread does Raoul live by Lake Lemna? He was steeped in the traditions of freedom—for every holiday his father would take him to some national shrine, so that he might learn as a child what being Swiss meant, and that the Confederation was a confederation of free peoples. How does he feel as the ring of slave countries draws closer and closer about his peaceful mountains?

Then Felicity—she was two when I first saw her. A golden haired doll who found the world so enchanting, she laughed and beamed on everyone to the pride of her adoring brothers, whose joy it was to show her off to discerning guests. What has happened to her? Where was she when the quiet English university town in which she lived was bombed? Have those proud brothers of hers gone flying off never to return? Were they in Norway, at Dunkerque, at Crete?

The children overseas have borne, and will bear, the heaviest load of this relentless war upon free peoples. Let us do what we can to help these others in the name of Him who said, "Suffer little children to come unto me, and forbid them not: for of such is the kingdom of God."—Ruth Taylor.

Record Company Congratulates Oldest Patron

Rose Snyder, Who Hoes Her Own Row at 93, is 5 Years Younger Than Buchanan

Last week the Record had the pleasure of receiving a renewal from one of its oldest and most valued subscribers, Miss Rose Snyder of the Mt. Tabor district.

Rose Snyder is now 93 years old. She lives alone on the farm where she was born, a few rods distant from the spot where her father, Jacob Snyder, built his log cabin on his arrival in 1842, the same year Buchanan was platted.

Miss Snyder is thus only five years younger than Buchanan. Her sister, Mrs. Maggie Herman, still living in the Bend of the River, is the same age as Buchanan.

Miss Snyder's family has taken the Record about as long as it has been published, which has been since 1859. Now due to a change in the road in front of her home she has to walk about a quarter of a mile for her mail. On Thursday morning of last week she walked the quarter of a mile to get the Record and gave a dollar and a half to a neighbor to take to the Record office. She paid just a little behind time—four whole days. Three years ago she was a day late, we remember, and sent his apology. When that happens it is because of difficulty in getting the money to town. She lives back from the road at some distance from neighbors.

Historic Hose House is Razed

The building on South Oak Street known as the "old hose house", and used as city headquarters for nearly or quite three quarters of a century is now being torn down by Carl Duis, to erect a house on 40 acres which he bought from John Diment adjoining the Hunter farm.

Duis bought the building from H. N. Batchelor, who bought the property from M. Lundgren. Batchelor is retaining the building to the south for use as a warehouse for electrical appliances.

The age of the building being demolished is not definitely known, but exceeds 75 years. During Civil War days it was city and fire department headquarters. In it was housed the old hand-pump, now a relic in the Three Oaks museum. Upstairs the Buchanan fire department held its regular meetings in days when it was a leading social and civic organization as well as the village defense against fire loss. One of the local men who used on occa-

sion to man one of the handles of the pumper is Harry Binns, who tells of the days when the department used to haul out the pumper every few days and set it over a flap door in the wooden bridge over the race where it crossed Oak street near the hose house. There they would practice shooting water over the belly of the old Christian advent church.

The old bell still in the belly rang the fire alarm for years, but was not installed when the building was first erected. For some time the bell on the old Advent Christian church, now on a mission at Canton, China, was used for fire alarms.

The village board of trustees met there since Civil War days until 1928, when the official city headquarters were moved to the Houseworth Radio Sales building, now occupied by a pool hall.

Committal services were held at the Gallen cemetery for Mrs. Sarah Bennett, brought from Fla. for Gallen Burial.

Stock-taking with us means consideration of all the interests of our customers, suppliers and our employees.

Officers and directors of A&P are confronted by this tremendous responsibility every day. Careers, human personalities and scores of other "intangibles" are in the balance. Shelves are easily restocked; not so these other factors.

After a series of "stock-takings," with pardonable pride we announce that, effective this week, all of the some 4,500 full-time store clerks in this area will share with fellow employees from coast to coast what we believe is the first 5-DAY, 48-HOUR WEEK in the history of the retail food industry, labor contracts and other local variables permitting.

To our employees in this division whose untiring efforts and efficiency have made possible the position we enjoy in the food industry, and to hundreds of thousands of satisfied customers whose cooperation we respectfully seek in making our new work schedule a success, we take this opportunity to reaffirm a few of the cardinal principles upon which A&P was founded 82 years ago by the late George Huntington Hartford, father of its present day owners.

The new work schedule is in line with a long-standing policy of A&P to give its employees the shortest working hours and the highest wages in the industry. It provides that wages of all employees will be the same as for the 52-hour week which has been in effect for several months.

It was in the cracker-barrel period a quarter-century ago that A&P boldly defied tradition and broke with the dawn-to-dusk hours of the grocery

business by reducing the work week from 72 hours to 65.

Regardless of the highly-competitive nature of the food business, A&P has always felt work hours of retail food store employees were too long. It has constantly sought ways and means of reducing them so that A&P employees could enjoy more leisure and, to a greater degree, the warmth and comforts of home life with their families.

Our recent decision to further reduce employee working hours once again has paced the industry in raising the living standards of retail clerks. Bateson Oil Well In Mich. Deepest East of Mississippi
Although drilling operations stopped recently at 10,445 feet, the Bateson oil well of the Gulf Refining company near Kawkawlin rates as the deepest well east of the Mississippi river, officials of the conservation department's geology division said today.
The previous record for deep drilling in Michigan was 6,676 feet at the Bates No. 1 drilled by the Newaygo Gas and Oil Company south of White Cloud in Newaygo county.
The Bateson well at Kawkawlin is the first in the state to produce gas abundantly in the "salt section," about 7,775 feet below the surface. Only traces of gas and oil has been found previously in the Salina formation in widely scattered wells throughout the state. The Bateson well was capable of producing more than eight million cubic feet of gas a day, oil operators estimated at the time the "salt section" was drilled.
Chemicals Applied To Fruit Trees Stop Ravages of Rabbits
When the snows blow next winter and the law-protected cotton-tail rabbits get hungry, valuable fruit trees won't be gnawed by the hungry animals if they are protected by a process perfected and patented by horticultural workers at Michigan State College.
By experimentation the process has been simplified and the materials now recommended do not curtail tree growth as some of the previous preparations indicated.
Rosin and ethyl alcohol are the ingredients. The rate is seven pounds of rosin to a gallon of alcohol. The rosin is pulverized and the mixture is permitted to stand 24-hours in a warm room. No heat should be applied as this not only is dangerous but would drive off enough alcohol to alter the composition of the mixture.
Rabbits have a habit in tough winter periods when food is scarce of chewing off tender areas of bark. Orchard operators call this girdling. It leads to tree killing or the necessity of grafting new tops. Surveys indicate the rabbits reach as high as two feet above the height of drifted snow, so that protection of the bark must extend to that probable height.
One gallon of repellent has been found sufficient to treat 150 to 200 two-year-old nursery trees. The exact number depends on size of trees and height of treatment.
A cheap brush is used for the application. The brushing is done while the tree bark is dry. Subsequent moisture causes a white precipitate but this does not affect the repellent results. One application has been found sufficient for a winter season.
Univ. of Michigan Home Study Dept. Serves Over 3000
More than 8,000 Michigan residents in all parts of the state attended school by mail last year, doing regular lessons and receiving corrected papers at home, through the correspondence study department of the University of Michigan Extension Service with the cooperation of the education and training section of the Works Projects Administration.
"Servicing the state" is the motto of the department which will offer 170 courses planned to meet the needs of out-of-school adults again during the coming year. Supervised correspondence classes are given at the high school level, as well as for college credit, and there are many vocational and avocational courses included in the 1941-42 catalogue.
A fee of \$7 per course will be charged this year for all residents of Michigan. Out-state students will pay \$10 per course. Enlisted men in the United States army, navy, marine corps, and all certified workers on WPA, NYA and CCC, are eligible for a special rate of \$2 per course.
The correspondence instruction is very thorough, Dr. C. A. Fisher, director of the University Ex-

tension Service points out. "Carefully prepared outlines of material to be covered, containing lesson assignments and such explanatory material as is needed, are sent to students. Each course has approximately 16 lesson assignments involving one week's work on the part of the student.
When the lessons are finished, the local supervisor assembles them and sends them to the University for correction. Instructors there grade the papers, carefully, note any mistakes, and write the needed, supplementary instructions on the lesson papers, which are then returned to the study supervisor for redistribution to the students. Independent students mail their lessons directly to the Correspondence Study Office."
Additional information concerning the courses may be obtained from Dr. Fred G. Stevenson, in charge of correspondence study, North Hall, Ann Arbor.
Conservation Dept. Advises Fencerow Nut Tree Culture
Farmers wishing to encourage fox squirrels should allow nut trees to grow in fencerows, as shade trees in pastures along lanes, and in woodlot borders, according to the conservation department field men at Rose Lake wildlife experiment station near here.
Open-grown trees getting plenty of sunlight develop large crowns and bear better crops of nuts and acorns than woodlot trees, the Rose Lake study discloses; providing squirrels with their chief food. Most yields were smallest in years in 1940, but fencerow hickories at Rose Lake averaged eight quarts of shelled nuts and walnuts bore from one to two bushels, while woodlot trees yielded practically nothing.
Science Enriches White Flour Diet
"And don't forget the enriched flour," may well be the postscript on many a grocery order in this year of 1941.
To the average person, enriched flour may just sound like another fact. The millers and nutritionists know it is good sound shopping to get the most for the money as well as helping the family to better health at no extra cost.
"Ours highly refined diets," says Roberta HERSHEY, specialist in nutrition at Michigan State College, "leave too small a margin between the person who is well nourished and one who is under-nourished, depending on how much of the necessary vitamins and minerals are contained in their daily meals."
The whole-wheat grains have in them a generous supply of vitamins and minerals needed by the body. All would be well if everyone ate one wheat excepting the whole grain flour or its products. When the white flour is made, a large part of the vitamins and minerals are lost.
Miss HERSHEY explains that enriched flour is white or near-white flour which has specified amounts of at least two vitamins, called thiamin (B1) and nicotinic acid, and also the mineral, iron, added to it.
As an extra bonus some enriched flour may also contain certain amounts of two other vitamins, ribo flavin and vitamin D, with two other minerals calcium and phosphorus, but these are not required.
The special milled enriched flour while classed as white flour is slightly darker, the kind made by adding vitamins and minerals looks and tastes like the white flour more commonly used. The special milled variety is to be preferred, although it may be more difficult to obtain right now.
Both enriched bread and enriched flour are foods, not medicines, according to Miss HERSHEY who points out that no more than the ordinary amounts should be eaten.
Thiamin is found in oatmeal, whole grain cereals, beans and peas, in nuts and lean pork products.
Nicotinic acid which has no relation to nicotine found in tobacco is plentiful in such meats as lean beef, chicken, liver, rabbit and corned beef. Lesser amounts are in milk, collards, kale, green peas, tomato juice and turnip greens.
The iron so necessary for good health is found in whole wheat and rye flour, in eggs, lean meat, liver, most greens, dried fruits, peas, beans and molasses.

If you have an abundant supply of apples on hand, and have run out of ideas as to what to do with them, try this recipe for sweet fruit pickles. It's simple and easy to prepare and will make a delicious meat accompaniment, especially for pork, veal or ham.

Sweet Fruit Pickles. Combine 1 cup vinegar, 2 1/2 cup white Karo, 2 inches of stick cinnamon and 6 whole cloves in saucepan and heat to boiling. Have ready 3 to 10 cups cored and quartered apples (pared or not). Cook 2 to 3 cups of apples at a time in the syrup, handling gently so they will not mash.

Escalloped Apples

6 large tart apples, 1/4 teaspoon salt, 4 tablespoons lemon juice, 1/2 pound peanut brittle, crushed fine.

Paré and slice apples, add salt lemon juice and peanut brittle. Place in buttered casserole and bake in slow oven (325 degrees F.) 1 hour. Serves 8.

Apples Melange Pudding

Toasted bread, hot milk, 1 dozen apples, Sugar, nutmeg, 8 eggs, separated. Cover the bottom and sides of a baking pan with toasted bread, moistened with hot milk. Core apples and cook them whole; sweeten with sugar and flavor with nutmeg. Beat the yolks of eggs together and pour over the apples. Place apples on toast, then cover with the stiffly beaten egg whites. Bake at 325 degrees F. 15 minutes.

Waxwings often are present in Michigan in winter. Considered the positest of bird species, waxwings here often are seen perched closely together, passing worms and chunks of pin cherries from mouth to mouth.

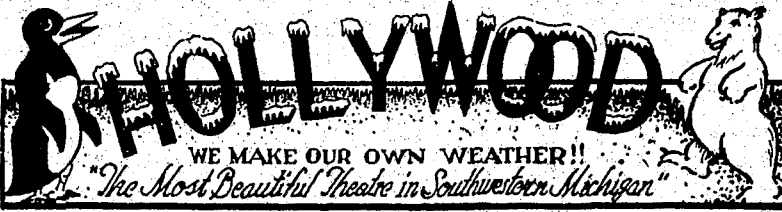
