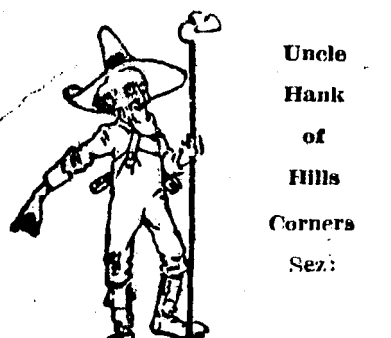
Clark Assoc. Selects Team for Games with Jackson, Battle Creek

CHAPTER 36 Development of Axle Business at Clark Plant

The decision to enter the axle business, made in the spring of 1913, marked the entry of the Celfor Tool Company into the automotive equipment business and the axle department was in production in late 1914 as the first division of the plant especially devoted to such production.

The Lee & Porter plant entered automotive axle production very soon after the arrival of Burrows, starting with an output of five sets daily and expanding rapidly in level gear drive passenger car axles. During the three total fiscal years during which Burrows was in charge of auto axle production, the output was: 1910, 240 sets of axles in one model; 1911, 800 sets of axles in two models; 1912, 1400 sets in three models. When the plant burned Burrows had just completed installation of \$300,000 in turret lathes, engine lathes, milling machines, drill presses, welding equipment and other machinery for auto axle production.

It was hardly possible that these developments could happen a half mile from the Celfor plant and not be noticed. After the fire Burrows went to the American Gear Company at Jackson, which had undertaken to complete some of the Lee & Porter contracts. From that place he was called by E. B. Clark in April, 1913, to discuss the possibility of starting the Celfor Tool company in axle production. As a result of that meeting Burrows entered the employ of the Celfor Tool company May 1, 1913. His instructions from E. B. Clark were to make a survey of the axle field, and to determine on an axle type. Burrows explored the field

CHAPTER 29 Papers of Former Buchanan Doctor Placed in U. M. Hist. Collections

Among the appealing figures of the buried past of Buchanan is one of a slight-built, but vivid, burn-haired young man who came to Buchanan with his young family about the time of the close of the Civil War to practice medicine.

The memory of Dr. John Anderson might never have been resurrected in print again had it not been for the fact that Mrs. J. F. Vile, the sister of his daughter-in-law, gave two of his notebooks to the University of Michigan. Historical Collections. The value of these notebooks to the University in the late fifties. The classwork, including a long treatise on the then-current practice in diphtheria, are written in a beautiful hand, embellished with flourishes but very legible.

Of interest to the general reader would be a number of graceful poems of his own composition, copied in the book. The artistic impulse appeared strong in the Anderson family, his son being Dr.

THEY CASH IN ON UNEMPLOYMENT

The following significant article on a service inaugurated by two jobless young men to find jobs for other jobless is taken from the December 25 issue of "Time."

Although unemployment is a primary U. S. problem, finding the right job is an important secondary one. There is no official U. S. agency to chart job trends and steer youth into the most promising occupations. Last year two smart, jobless young men started an unofficial agency to do it. By last week, when they finished their first year, their enterprise had grossed \$100,000 and they had become leading authorities on job hunting.

When Lyle Manly Spencer and Robert Kenneth Burns were at college (University of Washington), they were a famed world-touring debating team, and Burns was also U. S. champion (so named by Pictorial Review) at selling magazine subscriptions. They were graduate students at the University of Chicago when they raised \$16,000 from their friends and started Science Research Associates in a Chicago office. Their theory was that there were plenty of jobs to be had if people knew where to look. Now they have 55 researchers and writers studying industrial trends, new businesses, new professions, the 22,000 ways to make a living in the U. S. Their findings are published in a monthly magazine, Vocational Trends, and pamphlets, are sold (cost of complete service: \$17.50 a year) to CCC camps, 4,500 high schools, half the U. S. colleges and universities. Some findings:

Fastest-growing business is the slot-machine industry, which has increased tenfold since 1929, employs 70,000.

Each year there are 100,000 new jobs for truck drivers.

The notion that air conditioning and Diesel engineering will employ vast numbers of new workers is just a notion.

last year 100,000 went to Diesel schools, only 4,000 got jobs. Reason: Diesel engineering recruits most of its workers from gasoline engineers, who can learn Diesel work in a week or two. Similarly, air conditioning employs made-over plumbers.

Shortest-handed profession is research: it has 50,000 workers, needs many thousands more.

Instead of studying stenography (over-manned), girls should learn to operate business machines (undermanned).

The war is likely to help printers, aviation, chemical and railroad workers, is bad for cotton and tobacco farmers.

Suggested steps for getting a job: 1. buy a loose-leaf notebook; 2. keep a record of findings about yourself and possible careers; 3. prepare yourself for a particular career before you start hunting.

Biggest factor in getting and keeping a job is oomph: at least half of the men and women who lose jobs (except in Depression layoffs), are fired for maladjusted personalities.

Now the holidays are over and we must get back into the routine of everyday living. No doubt most of you have cooked and baked and stewed so much in the past few weeks that you are just a little weary at the thought of foods. Regardless of how we feel the family must eat. Here is a "Quickie" that is very easy and simple to prepare. A complete meal done in your skillet on the surface.

Braised Steak and Carrots with Mushroom Sauce and Browned Potatoes
 1 1/2 lb. round steak (cut thin)
 1 teaspoon salt
 6 or 8 small raw carrots
 6 medium sized potatoes
 1/2 cup flour
 1/2 teaspoon pepper
 2 tablespoons butter
 1 can mushrooms

Cut steak into strips large enough to wrap around the carrot once. Roll in flour. Season. Wrap each carrot in steak holding it fast with tooth picks. Melt butter in skillet. Add carrots wrapped in steak and brown on all sides. Arrange potatoes in skillet between pieces of meat. Add mushrooms with liquid. Turn to real low heat and cook one hour.

 (When daughter entertains at tea)
 2 cups grape juice
 2/3 cup boiling water

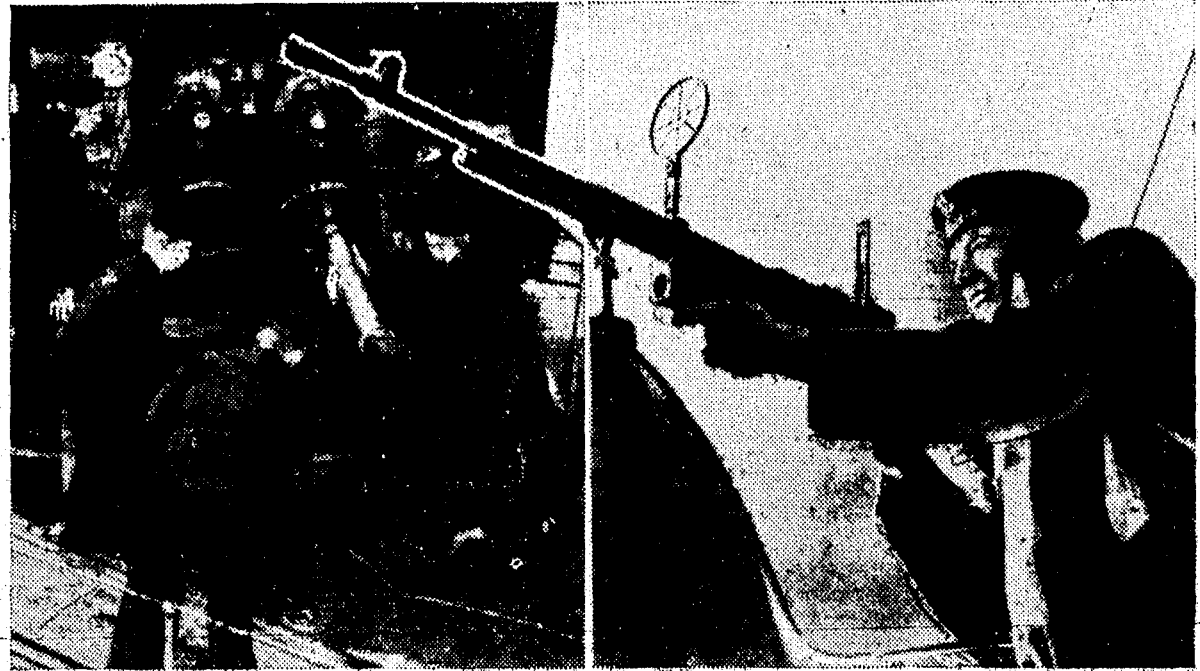

Job Tyler, and an oration was delivered by Mr. William Mottsam of Nottawa. There was also a fine dinner prepared by E. Johnson & Co.

The horsemen marched around once in the forenoon alone. The second time they were accompanied by the ladies, who marched with parasols, going two by two. On their return they marched double file to the place where the oration was to be delivered.

While the oration was being delivered the cannons were prepared to give a salute. At the close, this salute was given, and also after each feast during the dinner which followed. After dinner the horsemen formed and paraded about an hour and a half. They then closed with a dance of seven cotillions, and also two fights which were an indispensable part of the proceedings.

After Dr. John Anderson died his widow entered the University of Michigan with the first co-educational class and was graduated from the department of medicine. She returned to Buchanan and for a number years practiced here. Her black horse, Prince, and her buggy were familiar sights along the streets of Buchanan and the country roads. Sportsmen Club To Be In Charge

(Continued from Page One)
Department to cooperate with all interested agencies in attempting to work out some mutually satisfactory method by which farmland game may be increased, made available to sportsmen without unfair discrimination and without injurious trespass to the landowner.

The following plans are calculated to attempt to alleviate these difficulties and to promote better farmer-sportsmen cooperation:
Outline of Cooperative Farm-Game Management Policies
1. Each project shall contain a block of not less than 1,280 acres nor more than 10,000 acres of farm-game land, of which at least 85 per cent is in the association.
2. However, areas of less than 1,280 acres may be accepted under the following provisions:
a. They must contain at least 640 acres (one section).
b. The land included must be in a solid block; i. e., every landowner or lessee must be a member of the association.
3. Hunting on the project shall be organized similarly to the Williamson Plan.
4. The landowners or lessees must agree that no charge be made for the hunting privilege.
5. Landowners or lessees must agree to allow licensed small game hunters access to the project as determined by the by-laws or the association. The landowners or lessees are free to formulate their own by-laws, but such by-laws shall not conflict with the general regulations of the cooperative plan.
6. The hunting privilege shall not be retained for the members of any private rod and gun club or any other organization or group.
7. Each landowner or lessee agrees to the following required game management practices:
a. To refrain from unnecessary burning of swales, brush, and other suitable wildlife cover, and from unnecessary trimming of

fence rows and roadside cover.
b. To give reasonable assistance to the Department in obtaining such information as the number of game animals killed on the project, number of hunters, etc.
c. To permit employees of the Department access to the land at all reasonable times for censusing game abundance, checking hunters, etc.
d. To give reasonable cooperation in game law observance and enforcement.

8. The Department of Conservation wishes to direct the attention of the farmers to certain practices that are beneficial to wildlife, and the Department recommends that these practices be carried out by the farmers in so far as possible.
a. Planting of food patches, providing strips of unharvested grain, or placing corn shocks close to swales, wood lots, marshes, etc.
b. Providing winter feed close to winter cover in cases of emergency.
c. Maintaining permanent winter cover or nesting cover.
d. The use of a flushing bar.

The Department agrees:
1. To aid in formulating game management plans for the area.
2. To cooperate in game law enforcement.
3. To furnish signs for reasonable posting of the exterior boundaries and roads on the project area, provided final inspection shows that the specifications and requirements have been carried out in good faith.
4. To furnish a sign for each farm which calls the attention of the hunter to the provisions of the cooperative plan.
5. To furnish signs designating safety zones around farm buildings were requested by an individual landowner or lessee. Such requests should be mailed directly to the Game Division.
In case any member of the organization violates the agreement or charges for hunting privileges, the Department of Conservation reserves the right to cancel the agreement and remove the signs from the property where the violation occurs.
Suggested Procedure in the Organization of a Cooperative Plan Hunting Club
1. A cooperative hunting club should be a community enterprise. Some leader in the community (preferably a farmer) should attempt to interest his neighbors in the organization of such a club.

When sufficient interest has been aroused, he should call a meeting of all interested farmers. At this meeting the plan should be explained in detail. (Some member of the Game Division staff can usually be present at such a meeting to assist in any way possible if the farmers desire such assistance. Write to the Game Division, Department of Conservation, Lansing, Michigan, a few days in advance of the meeting if you want someone from the Game Division to attend your meeting.)
2. After the farmers have had an opportunity to discuss the plan, call for a vote, and if the majority favor the idea,
3. Elect officers, and draw up a set of by-laws governing the organization.
4. The secretary of the organization desiring to enter into such an agreement shall file a written request for cooperation with the Department of Conservation, and for technical assistance and signs. The secretary shall also submit with such a request a copy of the organization's by-laws, a plat showing the land included in the club, a list of names and addresses of the members, a statement that each farmer member has agreed to all of the required game management practices, and that all of the members have been acquainted

with the rules and by-laws governing the organization.
5. The meeting should be held early enough to insure that the work of organization can be completed early in September. The plat map showing the boundaries of the farms in the organization, the list of members, and the signed agreement should be mailed to the Game Division, Department of Conservation, Lansing, not later than September 20.
6. Samples of the agreement, which is to be signed by the officers of the organization, and of the signs will be sent or delivered by any farmer or group of farmers attempting to organize a cooperative hunting club.
7. Instructions explaining the proper use of the signs will be provided also.
