Tales of An Old Town

An Attempt to Reproduce a Cross Section of The American Scene, As Witnessed Here Through the Past Century

Through the initiative of Fred Richter, postmaster and historian of Dayton, the Record is in possession of material sufficient for an extended series of articles on old days in Dayton.

This should be of interest not only to Dayton people but to many Buchananites and others who by individual or family experience are connected with the past of that settlement.

Dayton has lost ground in importance as a railroad point and a trading and manufacturing center, its history in that respect paralleling that of nearly all small hamlets.

MEMORIES OF DAYTON

Originally the attractive part of Dayton was a hole in the ground, comprising a hundred or more acres, round and filled with water, fed by innumerable springs on the north, east and south sides with an outlet on the west forming what is now known to be the head of Galien river.

At the mouth of the "Big Bayou" is the frame work in heavy timber of a bridge just long enough to cross the channel of the bayou and with no approach at either side, or sign of road, evidently built before the water was raised by the dam seeming to question the story of the building.

The first mercantile business of which I have recollection was that of Jacob Luther and son, Andy. They did well—too well. After the "Big Fire" in Buchanan in 1861 they got possession of a lot in the track of the ruins and built the widest store on Front, the second building east of the present Princess theater, and moved to Buchanan and erected the residence now occupied by Pete Fuller and were of short duration.

One of the industries was the Henry Kahn wagon factory which lasted through many years, the wood working part on the east and iron shop opposite side of the street running north on the north side of the railroad. He turned out an excellent wagon.

Another industry was the brickyard, operated by a Mr. Wilson, to the northwest from the passenger house. I do not know how early the business was established but do remember going there for a load of brick when my father was preparing to move into new quarters from the log house in 1860.

There was an erratic character living about half up the hill and a few rods west of Mt. Zion road, in the person of Pete Nolan, and of whom there was the story that before leaving the "auld sod" he had been told that in America if he did not behave the Lord was likely to appear to him in some per story and below a pump room,

Edward Gomoll Dies in Chicago

Head Standard Paste, Glue Co. Had Developed A Beautiful Summer Home Here

Edward Gomoll, 45, a resident of Buchanan and Chicago, died at 12:50 p. m. Thursday in a Chicago hospital, of a heart attack which he suffered Wednesday.

Mr. Gomoll was head of the Standard Paste and Glue company of Chicago which he founded. Several years ago he bought the Black estate on River street.

Gomoll had been in ill health for a year. While transacting business over the United States he had spent considerable time in Buchanan, taking a great delight in the development of the old Black-Stryker farm. He had spent over \$30,000 in the development of an ultra modern poultry plant in which he hatched chickens and reared them to marketing size under hothouse conditions.

He is survived by the widow, Aleta Marrs Gomoll, whom he married in 1922, a brother, Alfred Gomoll of Chicago, and a sister, Mrs. George Roscoe of Chicago.

The body was placed in the Masonic home, Chicago, at 12:30 p. m. Monday to lie in state until the hour of the funeral at 2:30. Burial was made in Chicago.

S. Jankowski Is Drowned in Dayton Lake

Drowning Is First Tragedy of Its Kind in Dayton Lake

Funeral services were held at 9 a. m. yesterday from the Catholic church at Three Oaks for Sylvester Jankowski, 42, who was drowned Sunday evening in Dayton lake.

Father Julius Bona was in charge of the services. Jankowski lived with his parents six and one half miles southwest of Buchanan.

The body of Sylvester Jankowski was recovered at 10:30 p. m. by Under Sheriffs Robert Rinker and Joseph Kucera, who dragged the lake. The body was located in what is known as "The Nook," a bay of Dayton Lake stretching south toward M160. It lay in about six feet of water. A rather strange feature was that it was only about eight feet from the boat from which he had fallen, and which was not anchored. In the bottom of the boat were the victim's coat and fishing tackle.

Jankowski had rented the boat from Fred Gleisner at noon. About 4 p. m. Val Smith, who runs a filling station adjacent to "The Nook" saw the boat apparently empty and drifting and turned in a report to the sheriff. After the recovery of the body Coroner William Pifer of Niles was called and returned a verdict of accidental drowning.

Mr. Jankowski resided with his parents, Mr. and Mrs. Peter Jankowski, six and one-half miles southwest of Buchanan. Also surviving are four sisters, Mrs. Mary Klimke, Mrs. Jennie Plonski and Mrs. Helen Staniszevski, and South Bend, and Mrs. Bernice Bennett, and a brother, Joseph, both of Pontiac, Mich. Mr. Jankowski was born in South Bend Aug. 8, 1899. He was a member of St. Mary's Roman Catholic church in Three Oaks. Friends may call at the Swen funeral home.

Camp Madron Closes After Record Season

712 Scouts Attend, Gain 12 Pct. Over Last Year

Madron brought to a close the most successful season in its history, yesterday. Records in advancement, activities, waterfront work, pageantry, pioneering and handicraft surpassed anything previously done in past years according to Oscar Moll, Scout Executive.

At the last Court of Honor five boys were elevated to the Eagle Rank and the awards were made by the Scout Executive. The following were the Scouts to receive the rank. Andy Moses 34 Dowagiac; Jack Cain, 74 Niles; Don Graham and Richard Borsos of 71 Niles, and David Kramer of 53 Three Oaks. The ceremony of induction was very impressive and was witnessed by one of the largest crowds of visitors yet to be in camp.

Eight boys were recognized as Star Scouts, and three received the Life rank. Pioneer work included the building of two fine bridges during the season, and the trimming of trees in the new woods. This was done under the direction of Charles Smith, Director of Activities.

Special medals were won by the following—these are for the entire season: Bob Emery of St. Joseph won Rifle range medal. First lighting won by John Grathwohl of Niles; Morris Doddington, Benton Harbor won the bridge building medal; Berkie Preston of St. Joseph won the Archery medal. The best all around camper for the entire season was Bill Wilkinson, Troop No. 55 of New Troy. The staff made the selection on personality, cooperation, advancement, and participation.

Noll stated that while figures were not complete, it was estimated that attendance at the camp exceeded last years figures by 12%—712 being this year's total. It is estimated that over 5500 persons visited the camp during the season.

Plans for next season are already underway, and many more fine improvements are already being considered. Registrations are already on the books for the 1942 season.

Howard McClellan Wins Pilot Wings

Howard W. McClellan, son of Mr. and Mrs. Sam McClellan, 113 North Oak, is one of the 23 Army Aviation Cadets from Illinois, Michigan and Wisconsin who have won their wings as pilots and their commission as second lieutenants in the Army Air Corps at three advanced flying schools in Alabama and Louisiana.

The new officers are all members of 41-F, the sixth class to be graduated from schools under the jurisdiction of the Southeast Air Corps Training Center. A total of 310 young men received their wings and commissions in the graduation ceremonies.

The new officers received their commissions at the conclusion of a 30-week training course, which took them through the three principal phases of the Cadet program: primary, basic and advanced.

Army Aviation Cadets receive free room, board, uniforms, medical and dental care, and a pay of \$75 a month. When they are commissioned they receive the pay and allowances of their grade. When they leave the service, they receive a bonus of \$500 for each year on flight duty. Cadets must be between 20 and 28 years of age, single, in normal health and must be citizens of the United States.

William Doyle Victim Series Of Mail Frauds

Carl (Speed) Sanders and Ray Lawson Held As Accomplices

Carl Emerson (Speed) Sanders, 30, and Ray Lawson, 33, were placed under arrest in the past week, the former at Grand Haven, the latter in Buchanan, as the result of evidence allegedly showing that the pair have been systematically defrauding William Doyle, 114 West Alexander street, the entire amount of their take being estimated from \$2,500 to \$3,500.

Both are now under arrest, the former at Grand Haven, where he was taken on a warrant from the office of the United States Marshal at Grand Rapids, on a charge of having used the mails to defraud. Lawson was taken in tow by the police late Monday night and was committed to the county jail at St. Joseph until the extent of his complicity could be determined.

The first definite evidence was uncovered about a month ago when William Doyle, victim of the frauds, came to a member of the local police, Paul Kane, and asked him for a loan of \$80 in order to aid him to save an "estate" in litigation. Doyle stated that he had to raise \$180 at once to save the estate from reverting to the state of Florida, and that he needed \$80 to complete the sum. Kane told Doyle that if he would show all of the correspondence concerning the estate and prove that everything was "on the up and up", he would loan him the \$80. Doyle consequently brought a stack of letters and telegrams covering a period of several months which bore the suspicion of fraudulent conspiracy.

The letters were signed by a supposed "Atty. Nelson" of a Florida address. The representations contained in the letters were to the effect that a certain Kelley, who had been a comrade and friend of Doyle in the World War, had died, leaving an estate of \$10,100.29 to his old "buddy." However there were some legal preliminaries before the estate could be released. So from the time that the correspondence on the estate was begun Doyle was shaken down at regular periods on this and that pretext of the necessity for funds to save the estate. Much of the correspondence was by telegram to convey an impression of great urgency. During much of the time that this was going on Lawson was in Buchanan and Sanders at the receiving end in Florida. On receipt of the money, Sanders would send part back to Lawson, whose part in the game was evidently to keep Doyle interested in sending the money.

Representatives of the inspection department of the postoffice were called from Chicago and after they had investigated the evidence at hand they called in Ray Lawson. After questioning Lawson admitted being an accomplice of Sanders in defrauding Doyle.

Particular pathos is lent to this angle of the fraud by the fact that Doyle had befriended Lawson over a period of nearly ten years, since the latter's mother had asked him when she was on her death bed, to look after him. Lawson's mother had reared Doyle. Her son, Ray Lawson, did not work because of alleged illness. Consequently after his mother's death he was supported by Doyle, both by outright gifts and by means of money secured by pretext. Lawson lived with Doyle at the latter's home at 114 West Alexander whenever he was in Buchanan and boarded free of charge.

Under examination Lawson confessed and signed an affidavit covering the estate fraud and other frauds in addition. The operations began when the two young men induced Doyle to "loan" them \$700 to enable them to start a newsstand at Daytona Beach, Fla. Doyle was to receive a third of the profits as his share for financing the stand. Lawson confessed that there had been no intention of starting a stand, but that the co-conspirators had used the money to have a good time on. When that ran out, they started work on Doyle again, telling him that the newsstand had been closed by the police because

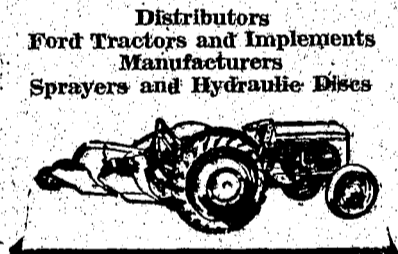

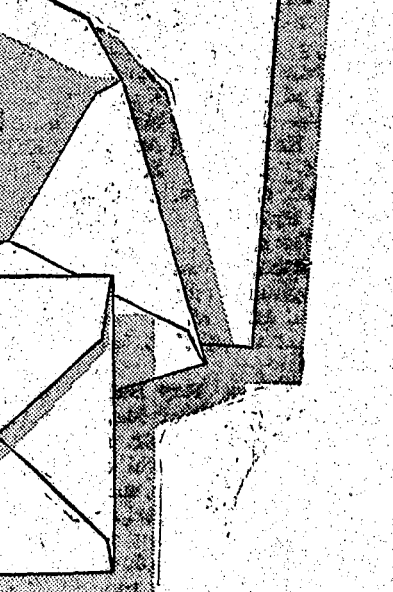

25,000 Michigan Farmers To Insure 1942 Wheat Crop

More than 25,000 Michigan wheat growers are expected to fill out applications during the month of August for Federal "All-risk" Crop Insurance on their 1942 wheat crop. Crop Insurance, offered only for wheat and cotton at the present time, guarantees an insured farmer at least 75 percent of his average yield against loss caused by any natural hazard.

To date, more than 145 Berrien County farmers have applied for wheat crop insurance and a total of 481 applications are expected in the county by August 31, the deadline for applications, according to Donald M. Hamilton, crop insurance supervisor for the Berrien County A. A. Committee.

August 31 was set as the deadline date for accepting crop insurance applications because a farmer must fill out an application before planting his crop if he wants crop insurance and most of

the wheat in Michigan is planted in September.

Mr. Hamilton said he expected an increase in the number of insured farms this year because of the relatively favorable wheat price due to the Government wheat loan program, which assures cooperating farmers 85 percent of parity loans.

The premium rate, which is computed on terms of wheat, is fixed for an individual farm according to the risk involved in growing wheat on that particular farm. The premium may be paid in actual wheat or the cash equivalent.

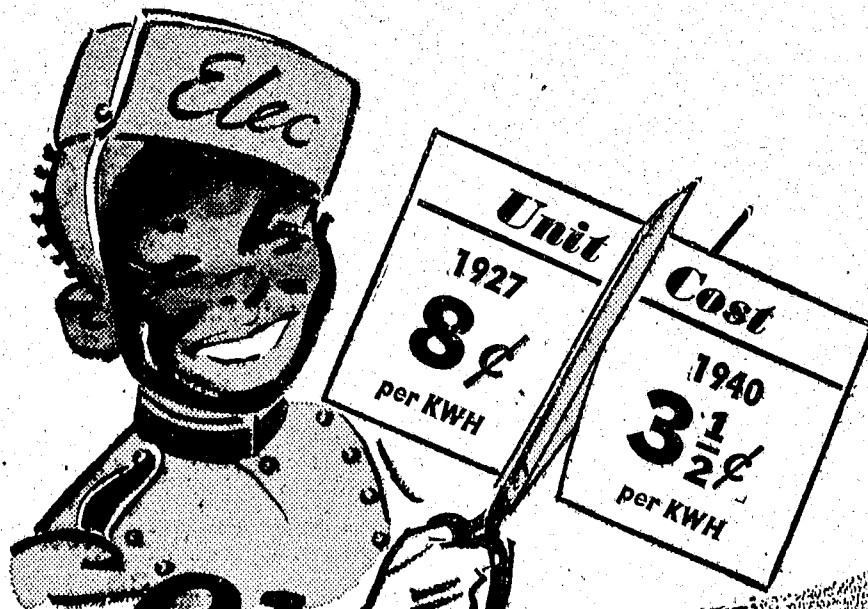
