#### WHY IS IT-NO PANIC.

There has been much talk about the stringency of the times. That money has been close there is no doubt. Every one almost has felt that it was so. But there is no great fluancial crisis nor any money panic. There is just as much money in the country as ever, and it is good. The money is not like it was in "wild cat" times, worthless. There have been fewer failures for 1869 than in 1868 : at least such is the case, taking the 1 sport of the Mercantile Agency of New York for the months of Novemher and December 1868-9, as a basis of calculation. During these months for 1808, there were 842 failures, and for the same time in 1869 there were હવાંપુ દેશ્વે.

The condition of business transactions are vasily different to what they were before the rebellion. The present status of the mercantile business, is well as other operations, will not p rmit of any great panic. Before the wer business of jobbing houses was done on long credit, while now it is done on a cash basis. The failure of one firm does not affect nearly so manv, as the same would have done in

1861. The little seare which the people experienced a short time since, by the gold gambling of Wall Street, has had a beneficial effect. It has caused the people to tread cautiously, and practice greater economy. The reult is, every one is trying to see how little money they can spend, instead of how much. Each one keeps a few to be entirely out. They seem to tear some undefinable something, financially. All these things tend to order of the day. Under the appro-

The great fall in the price of wheat has doi c more to limit the supply of currency in the West, than perhaps all other causes combined. There is, however, much wheat on hands unsold, and which will cre long be marketed. This will start some money afloat which now lies locked up in the farmers'

granaries. The business of the winter, too, will have its returns. during the Spring and Summer. The lumher, wood, staves and such like must bring a return, though, perhaps, not is abundantly, yet, with the increased economy by the people, it will accom thish the usual amount of subsistence. if not quite as large profits.



The question of woman suffrage is daily growing of more importance. The constant agitation will inevitably produce its result. The question, though at first scouted by many prominent persons, has, from its growing importance, elicited the attention of some of the first minds of the nation. It makes but little difference where any person stands upon this question, as the result is inevitable. To our mind no opposition can long delay the enfranchisement of the women of the United States. Whether such a step is wise or not, it certainly will be taken. And as to heartily advocating the move, we have not the least objection, so soon as we are assured that the majority of the women themselves desire the right of suffrage. In a government like ours, where a majority of the governed desire the right of suffrage, whether men or women, white or black. we think justice demands that the right should be conferred.

We are not yet, however, of the opinion that the majority of the women of the United States desire this privilege. This is doubtless the case to-day, but that it will be the situation a few years hence we do not believe. The agitation is commenced, and the cause of woman suffrage gains adherents, from both sexes, every day. As soon, then, as woman, as a class disfranchised, comes up and asks the right of suffrage, let it by all means, be granted. In fact, we cannot see how it can be denied her then, in keeping with the spirit of our Republican institutions. All the opposition to woman suffrage can only delay and not prevent the result. This we think is apparent to any one who will but consult the logic of events. The day will come, whether desirable or not, and croakers may as well submit with a grace, when woman's sphere will be greatly extended politicallywhien woman will vote, and hold office under the laws of the American Republic.
