The teeth are so important to life and health, that whatever tends to preserve them should be encouraged.

French Insanity.

It appears from collated statistics that insanity is steadily on the increase in France. From the 1st of January, 1801, to the 31st December. 1810, the number of mad under treatment amounted to 5,416; from Janu-ary, 1811, to December, 1820, to 8,372; from January, 1821, to De-cember, 1840, to 14,135. So that between 1801 and 1840 the numbers were almost trebled. The increase during the next ten years is even more startling. Between 1841 and 1850 the number reached 36,530. Again this number increased between 1851 and 1860 to 50,245. Since 1860 the numbers have steadily increased. In 1861 there were 6,266 mad poor; in 1862 the numbers were  $6,\overline{4}37$ ; in 1863 they were 2,659; in 1864 they were 6,877; in 1865 they were 7,234; and lastly, in 1866, they had reached 7,728. It thus appears that in the last year of which we have an official record there were as many mad patients under treatment in the asylums of the Department of the Seine as there were in ten years at the opening of the century.

STATE POLITICS.

Already there has been considerable said relative to who would be the Republican nominees for State offices. The names of the entire corps of our present State offices have been suggested for re-nomination. In addition thereto we notice the names of A. B. Witherbee, of Flint, V. P. Collier, of Battle Creek, and T. D. Gilbert for State Treasurer. S. D. Bingham, Editor of the Larsing *Republican*, for Auditor General; Gen. B. M. Cutcheon, of Manistee, for Lt. Governor; Daniel Striker of Barry County, for Secretary of State; Capt. H. A. Ford, of Niles, for Superintendent of Public Instruction.

In the first Congressional District, now represented by Hon. F. C. Beaman, who is also named as a candidate for re-election, the name of Hon, Henry Waldron, of Hillsdale is mentioned for Congress. The names being discussed through the press in this, Second, District, are those of Capt. J. C. Burrows, of Kalamazoo, and Gen. Stoughton, the present incumbent. Other names no doubt are thought of, but as yet none have been brought forward through the press. It is evident with the wide spread feelings of dissatisfaction expressed and felt against Gen. Stoughton, that his prospects for a re-nomination are not in the least flattering. His friends, however, are straining every nerve to secure his return to Congress. In this they will fail, if the people make their voice heard. As to the fitness and qualifications of Capt. Burrows for the position there is no doubt. And as to his popularity, in the District, no man stands higher; and we have no doubt of his nomination, if the question could be left to the people themselves. He is a man of undoubted integrity, of strict moral and religous habits, and one of the finest orators in the State. Just such a man as the people delight to honor, and such an one as political tricksters and dishonest politicians despise, because they cannot use him for the furtherance of their selfish schemes. We hope the people of this District will arouse as one man and demand the nomination of Capt. Burrows of Kalamazoo, as their Representative to Congress. The Third District, now represented by Austin Blair, has a number of candidates, as well as Mr. Blair for re-election. Several names have been presented as his successor, among them we notice, S. M. Cutcheon. of Ypsilanti, Chas. G. Gorham and John C. Fitzgerald of Marshal; Geo. Willard, of Battle Creek, and E. M. Barber of Eaton. In the Fourth District T. W. Ferry, the present member, is a candidate for re-election. Some talk of other candidates, but we have seen no names. presented yet. The Fifth District, represented by O. D. Conger, atands much as the Fourth. What the influences in these districts are against the present members we cannot say. At present their prospects seem good for re-nomination: The Sixth District has quite a number of candidates for the position of Mr. Strickland, the present incumbent. Among them we find the present member; John F. Driggs, the former member; Luther Westover, of Bay City; Major Huston, of Tuscola County; J. A. Hubbell; R. Sheldon, H. A. Burt, and W. E. Dickinson. The most prominent names presented for the United States Senatorship are Hon. J. M. Howard our present Senator, Hon. Wm. A. Howard, Hon. Austin Blair and Hon. F. C. Beaman.

This done, keep changing until the right man is found, and then, not out of courtesy, re-elect him, but because he proves himself worthy of confidence, and has shown his ability to represent his constituents. We were amused the other day, in conversing with a strong advocate of Gen. Stoughton's re-nomination, to hear him say Gen. Stoughton ought to be returned, as it has been Republican practice to do so, but he thought, however, that Gen. Stoughton was not just the man, or the best man for the place. 
