

FRANCE.

Again the prospects seem more fa-sorable for the success of the Government forces against the insurgents. Paris has really been entered by S0, 1:00 Versailles troops, and the latest dispatches place the communists forces in close quarters, with no prospeets of success. The civilized world has looked on since the close of the struggle with Germany with astonishment to witness the madness of the Paris Communists. It seems that they were not only determined to bring ruin on Paris, but also scatter the seeds of strife and devastation throughout the whole country. If they had succeeded in controlling, for a time, the French people, the entire business and industrial interests of the country would have undergone such a change as would have defeated the entire objects for which governments are formed. To fully imagine the state of affairs, if the Communists should succeed, it is only necessary to read the extracts we publish, in another column, from the programme of their principles and aims. Christian civilization thronghout the world will rejoice, at least, in the downfall of the Communists and their principles.

While the Communists are doomed, to failure in France, the future of that country is by no means flattering. If the Varsailles authorities are recognized, it by no means follows that their rule will be of any lengthy duration. The people and those holding the reigns of Government are distrustful of each other. There is no confidence anywhere-every one afraid of his neighbor. Just such a state of affairs exist most faforable to re-establish a Monarchy. That such will yet be the result we have but little doubt. The French people are not prepared for a Republic-they are not qualified yet for selfgovernment. It may, therefore, be confidently expected, that, even should the Versailles government gain some degree of stability, that a general vote of the people will unsettle affairs, if it does not at once declare in favor of a Monarchy. Bismark will look out. in any event, that the interests of Germany do not suffer. He, too, will have an eye to the establishment of such a permanent Government as shall tend most to the interests of the German Empire. That a successful Republic along side of Germany would have a strong tendency to unsettle affairs. in that Empire there is no question. This being settled, it is safe to conclude that Bismark, with his far-seeing ken will pursue such a course as in any event, if possible, to defeat the establishment of a stable French Republic, if such a thing could be counted among the possibilities. From our stand-point, if we were going to point out the best government for the French nation at the present time. under their peculiar circumstances, we should most certainly name a constitutional monarchy: This form of government would be a success, and would secure to the French people peace and quietude, which we imagine they can not enjoy under any republic which they may attempt to establish. Let information and education become as general in France as it is in Germany or the United States, and then a republic could be made a success. Till a different system of education is adopted by the French people, and knowledge becomes more general, a constitutional monarchy is unquestionably the best government that France can adopt.

PARIS May 22 .- All is over. Seventy thousand Versaillists have entered the city, and more are now coming. They marched in all night, coming through six gates, and met with but slight resistance. The barrierdes were, not defended. No. mines were exploded. The Verssillists are now moving on the Hotel de Ville. where the Communists will make their last stand. The Versaillists behaved splendidly, committing no excesses. VERSAILLES, May 22 .- The Commune troops rallied at Montmartre and Hotel de Ville, the approaches to which place were defended by barricades. Much serious fighting took place, and resulted in the Versailles troops occupying three fourths of the city. Montmarte is cannon.

The law, it seems, was voted to "take immediate effect" in one branch of the Legislature, but no vote was taken in the other House in the passage of the bill. The following statement has been given to the public by the State printer:

"By some error of an enrolling clerk, the new prohibitory law was made to take immediate effect. The Journal of the Senste shows that that body refused to give the law immediate effect. No prosecutions can therefore be commenced under it. until after the 16th of July. The State printers "followed copy," and are not responsible for the erroneous section appearing in the law in the pamphlet edition."

Some contend that unless both Houses vote to have a bill take immediate effect, after its final passage by a two-third yote, that it will not be enforced under 90 days. The law on this subject is as follows:

"No public act shall take effect, or be enforced, until the expiration of ninety days from the end of the session at which the same is passed, unless by a two-third vote of the members elected to each house."

The vote of "immediate effect" is added to a bill, after its final passage, by the Enrolling Clerk, on a certifi-cate showing that the above provision of the Constitution has been complied with. It is no part of the bill, and if one House votes to have it "take immediate effect," and the other House does not, no consideration of the affirmative vote need be taken. It does not effect the validity of the law.




