State of Michigan.

A Proclamation by the Governor. Whereas, By the provisions of an act of Con gress, approved on the second day of February, 1872, for the apportionment of Representatives to Congress among the several States, according to the ninth census, the State of Michigan less become entitled to three additional Representatives :

And Whereas, The rapidly increasing population and growing interests of the different sections of the State are such as to demand that a redivision of the Commonwealth into Congressional districts, conformatory to the provisions for increased representation, should be made before the next general election :

Now Therefore, I, Henry P. Baldwin, Governer of the State of Michigan, by virtue of the power vested in me by the Constitution, do hereby direct that the Legislature of the State convene in extraordinary session at the Capitol, in the city of Lansing, on Wednesday, the 13th day of March next, at 12 o'clock noon, for the purpose of dividing the State into nine Congressional districts, pursuant to the ratio of representation fixed by said act of Congress, and to consider and act upon all such matters as may be submitted by special message.

In testimony whereof, I have hereunto set my hand, and caused to be affixed the great seal of the State, Done at Lansing, this tenth day of February, in the year of our Lord one thousand eight hundred and seventy-two. HENRY P. BALDWIN.

TRIAL BY JURY.

Great damage and injustice have recently attended several cases of trials by juries, and there evidently is a desire growing in the minds of the people to have the jury system abolished altogether, except in those cases where such a trial is demanded by the parties. The right of trial by jury has been in vogue so long that "the memory of man runneth not to thecontrary." It was the pride and boast of the English common law, as transmitted to this country, and now incorporated into the laws of every State by legislative enactment. It has withstood the test of ages, and has, in the main, secured such fairness and impartiality until it has long been considered a sacred privilege guaranteed to every citizen when accused of any violations of the laws, to have his case submitted to a jury of his peers, technically termed "putting himself upon the country."

who hang about our court rooms for that purpose, known as "professional jurors," has worked great injury to the system, and the excluding from the jury box a man of intelligence because he has read some impartial account of the case in the newspapers, which he is sworn to decide according to the best of his judgment from the evidence and law produced before him, in its results often furnishes juries composed of men of the least information, and least competent for deciding fairly the complicated questions that are referred to them. Reforms in matters of such great importance should be made with caution, only after mature deliberation, for fear that in attempting to remedy an existing evil some unforseen harm will be committed in other directions. As in the handling of the pruning knife, care should be taken, lest in severing the smaller vines you clip off some of the main branches. Before abolishing the jury system altogether, we think that some of the present evils of the system should be remedied by proper legislation.

LAND GRANTS.

The land sharks are at their work in Congress. There are now twentysix land grant bills before the House and thirty before the Senate. These bills involve 200,000,000 acres of the public domain. Already there is being brought to bear a pressure to get some of these bills passed, and except the most determined vigilance is exercised, by our Senators and Represent atives against these steals, the country will continue to be robbed of her public lands. The imperative demand of the people is that land grants to corporations and combinations shall cease, and the Senator or Representative who votes in favor of any land grant bill hereafter will render himself unpopular with the masses, except the necessity for the grant is so plain as to be seen without argument. Reform, economy, and the preservation of the public domain for actual settlement. are the watchwords of the people. The public servant, whether in Congress or elsewhere, that arrays himself in opposition to these great items will soon or late, be made to feel that his services can be dispensed with, and that a more faithful one will be chosen in his stead. The people are fearfully in earnest on these questions, and they mean to have their sovereign will respected. It will therefore be well for all public men to take warning, and govern themselves accordingly.

CHICAGO NEWSPAPERS AND THE RELIEF BILL.

The Chicago newspapers are urg-ing with unabated and increased zeal the passage of the Chicago Relief bill. While this is true of Chicago papers, many of the most influential newspapers in other cities and throughout the country, are compelled to show the unjustness of the measure. This is no desirable task to apparentently stand opposed to granting re-lief to a stricken city, yet justice, right and the safety of the future de-all they "know about farming," for




