MONOPOLIES.

We are in favor of awarding to any inventor, for a reasonable time, exclusive privilege to manufacture and sail the article on which he obtains his patent, and to protect him in this light by all necessary laws prohibiting and punishing any infringement or violation of the rights thus guarantood. We think, however, that when any article has been manufactured which comes into general use among people of all classes, and the inventors and their heirs and assignees have enjoyed the benefits of the patent for a half century, and the inventive genius has been rewarded by making them all immensely wealthy, that it is time the Government should consider the rights of the people, and refuse to renew or, longer continue the peculiar privileges of the patentee. We include in this class what is known as the Mellier patent, and the patents held by the four leading sewing machine companies. Let us examine the history

of these patents briefly. The Mellier (straw paper) patent expired some five years ago by limitation, it then being the property of the Wood Paper Company, of Philadelnhia. An effort is now being made, after this lapse of time, and after the benefits of the original patent have been enjoyed, to have the patent renewed. Application for a renewal was made at the patent office, but the Commissioner of Patents did not consider that he had the authority to grant a renewal after the patent had expired. The parties interested, not wishing to be detected, then seek to get their exclusive benefits extended by having a general law passed by Congress, giving the Commissioner of Patents the power to grant renewals after the original patent has run out by limitation in cases where he thinks it proper. This law, of course, would meet their peculiar case and result in great injustice in many other cases. Since the expiration of this patent, five years since, millions of dollars have been invested in paper mills in | of an industrious, self-relying, law-abid different parts of the country, knowing that the exclusive privilege of the patentee were at an end. It is understood that the Wood Paper Company, in order to accomplish their purpose, have guaranteed to several extensive paper mills the perpetual right of the Mellier patent, thus creating a monopoly, while other mills, in case the patent is renewed, would have to pay a royalty for this privilege. This fact brings the matter directly home to the globe. people. It would result in the increased price of paper from two to three cents per pound, and would so enlarge, directly, this most important item of expense in the publishing of newspapers that many of them would be obliged to suspend publication en-tirely. It would make a difference in the yearly expenses of papers the size of the RECORD, with our present circulation of at least one hundred and fifty dollars, and some of our dailies an additional expense of from \$50 to \$100 per day. This amount would have to be made up in some way by the people, and go directly into the hands of this ring. Now one word in regard to the sewing machine monopoly, than which a more profitable or more oppressive one never had an existence in this country. All the machanical inventions necessary to a first-class sewing machine are held by four companiesthe Singer, the Howe, the Wheeler & Wilson and the Grover & Baker. Years ago they formed a combination the present sesison of Congress. for mutual benefit and protection, and though manufacturing different machines they are really not rivals in business. They have reaped an enormous harvest by compelling every person who purchases a sewing machine to pay from \$60 to \$150 for a piece of mechanism of which the whole actual cost does not exceed \$10 to \$30. It is estimated by our best and most reliable mechanics, that the cost of manufacturing an average sewing machine, exclusive of table or case, does not exceed \$5 or \$8. The number of machines sold during 1870 was 343,590, at an average price of \$65, according to the sworn statement of officers of these four companies. The enormous profits to these companies, during this one year alone, were over \$12,000,000. They have enjoyed these enormous profits for twenty years, and now, when of these patents is about to expire, the "feed of A. B. CONGRESSIONAL. SENATE, Feb. 18.-The House bill llowing under the Bankrupt law the exemptions allowed by the laws of each State in 1871 to be valid against debts contracted before the adoption of such law, as well as afterward, was passed. The American and Asiatic Telegraph Bill was passed ; also, the House bill for relief of settlers on the Sioux reservation in Minnesota. The Vice President laid before the Senate a petition of Simpson, of coun-sel in the Pomeroy investigation, asking capital, to whom money was offered by agents and friends of Pomeroy for voting for him, and after debate a resolution was agreed to directing the special committee to inquire into any allegation of bribery or corruption by Pomeroy in the Kansas Senatorial election. A bill was reported for promoting education in the Southern States. HOUSE, Feb. 13 .- The report of the Poland Credit Mobilier Committee was received. It recommends the expulsion of Ames and Brooks, and exonerates the other members named in connection with the Credit Mobilier. The remainder of
