The bill also provides that schools refusing the uniform books adopted by the county Board shall not be entitled to the public school money.

By the operations of this bill there will be a uniform system of school books in each county, and this list cannot be changed oftener than once in five years. This will be of immense value to the several districts, where almost every new teacher has some new book that he desires introduced. It will also do much towards defeating the school book swindle and exhorbitant prices therefore, as competition for a contract for five years will induce the lowest possible figures. We trust therefore the bill will pass the Legislature. If it cannot succeed as a general bill; we hope it may as a local bill for Berrien county and a few other counties that greatly desire the bill to become a law.


