This as effectually withdrew just so much currency from circulation as a "Wall Street lock-up," and of course rendered matters worse. People are not afraid of the currency, but distrusted all banks, because of the suspension or failure of one of the leading banking establishments in the United States. So, as fast as possible they de-manded their "monish," feeling per-fect confidence in the currency. The banks, foreseeing this state of things, death. We trust, now that the excitement is somewhat allayed, that business again will resume its wonted channels. This will be the case if the people only so will it. Instead of hoarding currency at the present time it should be put in circulation. No man should keep currency for a single day locked up in his poeket or private safe. The currency is needed to do the business of the country, to move the crops, and to restore general confidence.

few exceptions, had so good securities as they now possess. Then why this on this point. alarm on the failure of a few-in fact one leading banking house? People argued if J. Cooke & Co. have failed then all others must also fail. "I will therefore get my money from the bank and look out for it myself." This was false reasoning, as the cause that produced the failure of this great house, did not exist to produce the failure of the great mass of the banks. of the country. J. Cooke & Co. were large holders of Northern Pacific stocks. These stocks were slow of sale, and the house could not carry this great load which it had assumed, in hopes of a rapid sale of these stocks, so the great banking house of J. Cooke & Co. had to succumb to the pressure. The thousand banks of the country are not, however, great holders of these uncertain railroad securities, and hence the cause that produced this first great failure does not exist to weaken. the great mass of the banks of the country.

Undoubtedly, as has already been claimed, the great agitation of the railroad monopoly question by the granges and press of the country, had something to do with the depreciation of railroad stocks, which, to a certain extent, caused the failure of J. Cooke & Co. Of course that house depended upon the sale of Northern Pacific railroad bonds to carry through that great enterprise. The wide spread feeling against railroad monopoly created in the minds of capitalists a distrust of railroad securities. The result was that foreign capitalists, as well as the moneyed men of our own country, ceased to invest in the Northern Pacific bonds, and as a result the great house carrying that enterprise on its back had to tumble down.

The ultimate result of this railroad agitation will be, undoubtedly, to depress the stocks of these corporations in the market, and to retard the rapid building of new railroads. The capitalists, and many shylocks, of course will be a little shy of investing so heavily in railroads, if these corporations are to be put, as they undoubtedly will be, under due restraint, where they cannot unduly extort unreasonable freight and passenger charges.

Congress must, however, come to the final rescue, to enable business to be carried on without loss to the great commercial interests of the country. There must be some plan provided whereby the currency may be made adjustable to the necessities and demands of business. Some plan must be adopted whereby the withdrawal of. currency from circulation, either to corner the same, or in case of a financial panic, to hoard it up, can be counteracted. We know of no better plan than for Congress to enact a free banking law, or authorize the exchange of U. S. bonds for currency and vice versa, at the pleasure of the holder. When more currency is needed the bonds will then flow to the Treasury and there be exchanged for currency, and when less currency is needed, the surplus will go to the Treasury to be reinvested in U.S. bonds,




