#### RARD TIMES.

The New York Tribune contains an article in relation to the exports and imports of this country during the past few months, and draws.some conclusions which are worthy of careful consideration, and which we give below. It is a very gratifying fact that for several months past notwithstanding the constant flow of gold and silver from this country, the exports have largely exceeded the imports. In December lest the excess was almost \$30,000,000, and it promises to be. much larger for the current year than for that ending June 4, 1874. The balance of trade is expected to continue largely in our favor for some time to come. What the Tribune finds for gratulation from these facts are the following:

First. This result is largely due to financial distress, and the consequent retrenchment of the people. There has not been, in the first place, a demand for imported articles, and in the second place, the debt contracted abroad in the years of excessive importations, is in course of payment. We are, in short, settling the balance against us.

No poverty,-absolute Second. poverty, we mean,-exists among the bulk of our mechanics, laborers, and farmers, and this is shown by the fact that there has been no decrease in the importations of tes, coffee and

sugar. Third. The economy practiced by the people is shown in the falling off in the importations of cotton, woolen, silk and linen goods, showing a large saving in the matter of dry goods.

Fourth. The imports showing the greatest decline are in iron and steel. In some important kinds of iron work our exports are now nearly as large as the imports.

The conclusion to be drawn from these facts is that while the present large exportations are due to the exceptional state of affairs, mainly arise ing from the panic of 1873, a foreign market is constantly making for our goods. The value of our exports of iron and steel is now from \$12,000,-000 to \$15,000,000 a year, and the exports of cotton goods have doubled since 1872. One hundred and fourteen thousand packages of domestic cottons have been exported from New York and Boston in the first three and a half months of the present year, the quantity being larger than for any corresponding period since 1861. 



## TAXATION.

The amount of taxation for the years 1875 and 1876 according to the appropriations made by the last ces-sion of our State Legislature is respectively \$174,732.50 and \$232-250.00. This does not include the total amount of taxation to be raised as the previous Legislatures made appropriations for the State Asylum. the new Insane Asylum and the State University, amounting to over \$330,000 for each of the years 1875

and 1876. The total amount of taxation for 1875 and 1876, therefore, will foot up about \$540,000 for each year. This is nearly \$400.00 less that it was last year, and but a trifle less than one-half of what it was in 1873-it being then \$982,280.50.

The following table shows the oppropriations of the last Legislature for the State benevolent, educational and other institutions for the years 1875 and 1976:

"This is in addition to the regular Unnit versity appropriation of \$31,500 under act No. 32, 1873.

There are appropriations for the Fish Commission, for the Centennial, for the State Pioneer Society, and also appropriations above mentioned, made by the previous Legislatures for the State Capitol, New Asylum, (amounting to some \$300,000) that the above table does not include. During 1875 and 1876 \$32,500 are to be raised by special taxation and \$10,000 appropriated from the general fund, each year to pay for the original plans of the State Capitol.




