





Lice may be excluded from poultry houses by syringing the cracks and crevices in which insects of any kind harbor will effectually disperse them.

Horse-radish, grated and mixed in vinegar and applied to the affected part, is a sure and simple cure for nenralgia.

Hoarseness, or tickling in the throat, may be alleviated by allowing a little powdered borax to dissolve on the tongue and run down the throat.

To whiten stained porcelain-lined kettles fill them half full of boiling water, throw in a tablespoonful of powdered borax and boil for a few minutes.

A few drops of carbolic acid in paste made of gum tragacanth will prevent it souring. The paste is also improved by the addition of a third part of its quantity in gum arabic. It is asserted that hard water may

be rendered soft by boiling a twoounce vial in a kettle of water. The carbonate of lime and other impurities will be deposited in the vial. Try it!

MINCED FOWL .- Take the remains of a cold roast fowl and cut off all the white meat, which mince finely without any skin or bone; but put the bone and skin in a stewpan with an onion, a blade of mace, and a handful of aweet herbs tied up. Add nearly a pint of water. Let it stew for an hour, and then strain and pour off the gravy, putting in a teaspoonful of Worcestershire sauce. Take two hard boiled eggs and chop them small. Mix them with the fowl, and salt, pepper, and mace, according to taste; put in the gravy, also half a teaspoon ful of lemon juice, two tablespoonfuls of flour, made into a smooth paste with a little cold water, and let the whole just boil. Serve with sippets of toasted bread. Some persons prefer cayenne to common white pepper.

ORANGE TART .-- Grate a little of the outside of an orange, squeeze the juice into a dish, put the peel into water, and change it often for four days, then put it into a saucepan of boiling water on the fire; change the water twice to take out the bitterness, and when tender wipe and beat them fine in a mortar. Boil their weight in double refined sugar into a syrup, and skim it; then put in the pulp and boil all together till clear. When cold put it into the tarts, squeeze in the juice, and bake them in a quick oven. Conserve of orange makes good tarts.






