Graham, or Breakfast Gems-Take or e and a half cups of sweet milk, a a little salt; then stir in Graham flour sufficient to make a stiff batter, first adding to the batter two tea-spoons. he baked in moulds or patty pans, first made hat upon the top of the stove. Terop in your batter with a spoon, and bake in a hot oven.

White Muffins-- One pint of sweet r ilk, two eggs, a table epoan of yeast, f mr enough to make a stiff batter, a t.ble-speen of butter-let stand in a varm place to rise. They can be Laked in four or five hours, either in n.uffin rings or waffle irous.

Corn Meal Muffins-Two cups of sweet milk, two eggs. a little sugar, two cups of corn meal and two cups (f wheat flour, a smalpiece of butter. and two tea spoons of baking powder. Bake in muffin rings.

Het Water Gisger Bread-One rup of molasses, a full table spoon of hutter or lard, (or meat drippings can be used), one tea spoon of ginger, three fourths of a cup of boiling water in which is dissolved a tea-spoonful of soda, add about two cups of flour, using care not to make a too stiff batter.

Toast, German Style-Tako slices of bread, such as you want to use, cut rather thin. Have a batter made by taking one quart of flour, three eggs, a little salt, flavor as for custard (not cooking it). Dip the sliced bread into it and fry brown upon a hot buttered griddle. Serve as desert for dinner, with sauce, or for tea.

Vinegar-Keep your vinegar jug, vessel, or barrel, full as possible. I had some excellent cider vinegar that was bought last year, not using it all, into what remained I poured a little cider, and I kept doing so, and the result is a good supply of good vinegar. The new cider of this year, 1877, was soon transferred into old vinegar of 1876. The trouble this year is to get the cider, but a barrel of cider is indispensable for good vinegar.

THRUST IN HORSES' FEET .--- There

THRUST IN HORSES' FEET.—There is no disease to common as thrush in horses' feet especially in the hinder ones. To treat with success this af-fection the stable should be kept dry and clean, and the frog and sole should be cleaned off morning and evening. Every fourth or fifth day a pledget of tow, or oakum, charged with Barbadoes tar, may be introdu-ced into the commissures. If the horse is not required for work let the shoeing be omitted, but attend to cleanliness and the occasional removal of loose and detached shreads or lay-ers of horn, which only tend to harbor filth and engender decsy of the healthy frog. The frog should never be pared more than just enough to remove loose shreds. It may be necessary to is no disease so common as thrush in loose shreds. It may be necessary to continue the treatment for some time, until all symptoms of disease disap-pear. A clean and dry floor is essential to retaining a healthy state of the horse's feet. To let a horse stand all day in his own wet and droppings is sure to produce mischief sooner or later.-Prairie Farmer.





HINTS FOR HORSE-OWNERS .--- If a colt is never allowed to get an advantage, it will never know that it possesses a power that man cannot control; and if made familiar with strange objects, it will not be skittish and nervous. 




