Bran Good Food for Hogs.

Bran will do your hogs no harm afther wet or dry, but as millers, with the improved machinery, now sift it, the bran fed alone is not relished by hogs, unless forced to it from hunger. Bren, when mixed with shorts, ground rye, barley, or corn in proper consistanoy to make it relistable and digestible, becomes one of the most valuable foods for hogs. In fact, it contains properties not possessed by corn to a sufficient extent to supply the animal nature, and for this reason the bran is too valuable to be wasted or fed carelessly. If farmers would prepare a portion of the daily food for their hoge, composed of two parts of wheat bran and one part of some richer and more delicious food in addition to the corn during fattening time, they would reap results they never dreamed of. Much of the disease among hogs comes from the lack of this thoughtful care. The bran builds up the bone and the musentar system, keeps the bowels regu-In. and tends to promote a normal and he Ithful growth in the animals. If no better facilities are at hand the food may be prepared in a large barrel each morning and fed in the evening. 'With a few gallons of hot water in the bottom of the barrel, and a portion of the mess stirred in first, the whole will became sufficiently variand to stars fermentation enough to eventen and make it relishable, and prevent freezing, if the barrel is covered over with a thick cloth. Mix in about the amount of salt necessary to supply the wants of the hogs. Breeders and feeders of swine do not thick enough of these things in caring for them. These attentions require some trouble, but the pay is much better, as a rule, than that

Food for Fowls.

A writer in the New York Herald says: If hens are rightly cared for they should pay from 200 to 300 per cent profit as layers. They must not be stinted as to space, nor too many kept together. If confined allow at least a square yard to each fowl. Imitate as closely as possible the condition of the hen in summer and supply by artificial means the wants which nature supplies in warm weather and hens will lay in winter. Let the floor of the hen house be of dry earth, with a box of dirt and ashes for their quarters cleaned by removing their droppinga at least three times a week .---Give free ventilation. Suppose your hens to be in good condition and health when they commenced lying, give them the proper food to keep them so .---Buckwheat and wheat are the best grains, although for variety other must be given. Give feed in various ways every day. Mush is excellent, as is also fresh meat and scraps from the kitchen. Two or three times a week give fresh bones and ground bones, with gravel and and broken oysters shells, always within reach. Apples, cabbage,-turnips and onions, raw or cooked, will be relished. The later in life a pullet commences to lay the longer she will continue to lay, and the greater will be the uniformity in the size of her eggs. A good Houden hen will average from 100 to 150 eggs a year; but to average that, a flock must have good care. Thick sour milk or buttermilk is an excellent article of diet through the heated season. The-Houdans are very prolific and will stand a great deal of cold, but must be kept dry. The Plymoth Rocks are almost constant layers and bear confinement well. Their eggs are large and very even insize. Although their frame is not so large as the Brahmas they are more plump and fatten. readily.




Country Schools.

It is scknowledged on all hands that the great need of the agricultural community at the present day is a higher sed more general education, and no chance of attaining this should be suffered to pass unimproved. Not only should all the children, therefore, in every neighborhood strend achool whenever possible, but, care should be taken that nothing should be done to prevent them from deriving the greatest measure of benefit. from their a tendance. The selection of competent teachers and the preservation of their legitimate authority and influence are essential to this end. The school hours in the country are generally somewhat longer than in cities, yet in the latter many skill ful physicians advocate their curtail ment. Country school houses, how ever, have a decided advantage over those in most of our cities, in that

they are, as a rule, better ventilated less crowded. Moreover, the and open fields and unpoluted air afford abundant opportunities for healthy exercises, denied to those whose lot has been cast amid brick and mortar. It is important, however, that this exercise should not take the shape of

imposed chores after school hours. If parents only reflected on their own juvenile days and on the discontent and repugnance to which such extra duties give rise in their own breasts, there would be much less of this per nicious practice. 



Says the American Agriculturalist : -Some time ago we introduced to the notice of our readers the Langshan, a variety of fowls that had been recently imported into England from a part of the Chinese Empire. Since then, further experience with these fowls has given them a favorable reputation, and we see it noticed in the English papers that they are proving to be very early layers and excellent table fowls. A correspondent of the London Tive Stock Journal reports, that he had eggs from pullets only $4\frac{1}{2}$ months old, which is remarkable, even with the most precocious specimens of the breeds noted for early laying, An importation of these fowls has been made by Mr. Edward A. Samuels, of Waltham, Mass., and if the reputation they have made in England is maintained in this country, we expect them to become very popular.
