Rules and Regulations For the Government of Plumbers and Partisan Using Water from the Village Water Works.

Sec. 1. Be it ordained by the Board of Water Commissioners of the City of Buchanan: That the rules and regulations hereinafter named, or which shall from time to time be adopted, shall be considered a part of the contract with every person, company or corporation that is supplied with water through the water system of the village, and every such person, company or corporation, by taking water shall be deemed to accept and agree to be bound thereby, and whenever any of them is violated, or such other as the Board may hereafter adopt, the water shall be cut off from the building or structure, and shall not be let on again except by order of the Board, and on payment of \$1.00, the expense of shutting it off and turning it on, and of the terms as the Board shall determine, and a satisfactory understanding with the party or parties that no further cause of complaint or objection shall be entertained by the Board shall have the right to declare any payment made for the water by the person committing such violation to be forfeited, and the same shall thereupon be forfeited.

Sec. 30. All service pipes, stop-cocks and other apparatus must be sufficiently strong to bear the run of the water in the mains, and all service attachments should be provided with a stop and waste-cock for purpose of draining the pipes on the premises.

Sec. 31. Square-faced unions shall be used on all branch pipes, and plumbers must insure (if required by the Board) a thin metal disk to govern the supply.

Sec. 32. All fixtures for constant or intermittent use, such as water closets, wash-basins, and the flow regulated by valves and disks. Plumbers must report each month all disks placed, giving their exact location in each premises.

Sec. 33. Proprietors of hotels, halls and lumber yards, or manufacturers desiring larger service pipes than that used for ordinary purposes must apply to the Board, stating purposes for which the water is to be used.

Sec. 34. Fire protection permits will be issued by the Board to regular consumers. No permits for such purposes will be issued to non-consumers.

Sec. 35. Any person making application for a meter to be set in his premises shall be subject to pay all costs of furnishing, setting, and regulating such meter. Service pipes to such premises must pass through the meter. No meter shall be set on any premises except for the purpose of estimate by the Board unless the rate for such meter is included in the sum of fifteen dollars. Meters must be placed where they are secure from freezing, and the connecting pipes of meters shall be jointed with square-faced unions, and a stop and waste-cock inserted in each service run where it enters the building.

Sec. 36. Plumbers will report the setting of all meters, their location and size, the number of branches from same, together with uses of water, to the Board. No meter shall be removed from the premises where it has been set, except under the written permit of the Board.

Sec. 37. Parties wanting premises before expiration of the term for which they have paid, to obtain the application of rate paid on other premises, or rebate on such rate, must apply to the Board, when, upon a proper showing, the transfer of the premises will be entered or other proper allowance made.

Sec. 38. All applicators changes will continue from April 1 to October 31 in each year, such charges to be based on the dimensions of premises. Proportionate charges shall be made for longer use than that specified above.

Sec. 39. All parties are prohibited from using water for the flushing of sewers, the setting of any pipe in ditches, or any description of building purposes, without having obtained a permit therefor from the Board, except by plumber while laying the same.

Sec. 40. All parties are prohibited from obstructing free access to any fire hydrant, water gate or stop-cock in the public street, and from depositing any rubbish or building material in close vicinity to the same.
