### MISS ELLEN STONE

Climax of Fine Program at Benton Harbor Assembly on Wednesday.

The world renowned missionary Miss Ellen M. Stone was no disappointment to her audience as she lectured last Wednesday at the assembly for over two hours, holding the vast audience of over 3000 in rapt attention.

Miss Stone was introduced by the Congregational minister of Benton Harbor, Rev. W. J. Cady, as this was the church under whose board Miss Stone had gone out. She gave in the introduction of her talk a very interesting description of the geography and topography of the countries, where she had spent 24 years of her life. The brutality of the brigands and the indignities Miss Stone and Mrs. Tsilka suffered seemed a hundred fold more real and more terrible coming in spoken words from the lips of the captives than when read in our periodicals.

Miss Stone is a woman of charming address and looks much prettier in new up-to-date gowns than in old fashioned pictures which are shown of her.

There were 100 people went from Buchanan to the assembly on Wednesday and proportionately large delegations from the surrounding towns.

W. H. Keller's brother, T. H. Keller of Hamilton, Canada, who recently was a guest in our village for a few days has returned to his home and gives to the "Hamilton Spectator" a glowing description of his trip. He was delighted with the country and says in part:

Leaving Macatawa park, you journey southward a hundred miles or more through the Michigan fruit belt to South Bend, Indiana, which is picturesquely situated on the extreme southern bend of the beautiful St. Joseph river. Within two miles distant from the center of this city are the celebrated educational institutions of Notre Dame university and St. Mary's academy, the most extensive Catholic seats of learning in the United States. Four miles away to the east, and connected by electric railway, is located the flourishing city of Mishawaka, which place is also widely noted as a manufacturing and business center and connects by inter urban electric line the cities of Goshen and Elkhart. South Bend has grown to a city of 40,000 or more people. It has the Studabaker Wagon factory and the Oliver Plow works, the largest of its kind in the world, and when the British government wanted a rush order for the Transvaal during the recent war between the Boers and the British, it was the Studabaker company that got the order.
