CARS COLLIDE AT HIGHWAY CORNER

FORD WITH SEVEN OCCUPANTS AND WILLYS-KNIGHT CON. TAINING FOUR, COLLIDE ON THE GALIEN ROAD.

Two automobiles came together with considerable force at the turn in the Galien road at the Bakertown cemetery, Wednesday afternoon, with rather serious consequences. Ed. Hooven with his wife and five children were driving from Detroit to Kenosha, Wis., in a Ford. They had passed through Buchanan and were driving towards Galien. As he approached the turn in the road at the Bakertown cemetery Mr. Hooven stated that the sun blinded him, and he stopped his car and waited long enough to make sure that other cars were not rounding the corner from the opposite direction. Mr. Hooven had completed the turn at the corner and was on straight road when he noticed a Willys_Knight machine coming towards him, and before either of the drivers had time to change their course the machines came together with terrific force. The Willys Knight machine was occupied by a Chicago man, his mother, and two girls. One of the girls in this machine sustained cuts about the face and head, and the others were severely shaken up. Mr. Hooven's little son, probably years of age, was thrown from the machine and nearly across the road by the impact. He received a se_ vere cut in the forehead. The other members of the family escaped injury.

The two parties came to Buchan_ an for medical assistance, and the wounds of the injured girl and boy were dressed by Dr. Snowden.

The Willys_Knight had its bumper torn off. the running board and door damaged; while Mr. Hooven's Ford had one of the front wheels torn off, a spring broken, and was other_ wise damaged. The Chicago people continued their journey, going from here to Niles, shortly after the accident while the Hooven family remained in Buchanan until the necessary repairs could be made on the machine.



LANSING, July 23-Michigan's counties have more than \$6,000,000 coming to them if all state road re_ wards are to be paid, according to a statement of the awards due July 1. 1924. The statement was prepared by State Road Commissioner Frank Rogers for submission to a committee of the state administrative board which is considering future ac_ tion upon the payments. The total is \$6,198,060.10.

Berrien and St. Claire counties, with almost a half million dollars each, are the largest amounts re_ ported but 22 of the counties have more than \$100,000 listed as their

Townships of Berrien county will receive \$26,924 under the state administrative board's decision to dis_ tribute \$376,372 rewards past due to townships in the various counties of the state on July 1, under the Cov-

Some of this state indebtedness due the counties and townships dates back some four years or more. Recently this matter has been criticized severely by opponents of the present state administration, and this action in paying the small share due the townships is naturally expected to allay some of that campaign "noise." It is further understood that a proposal to pay all counties whose total accounts are \$10,000 is being considered.

Townships in two counties will receive over \$70,000 of this state re_ ward money to be paid at this time. Allegan county townships will re_ ceive \$36,013 and Lenawee county \$37,147. Huron county will receive \$19,543, Hillsdale \$29,989, Berrien, \$26,924, Marquette, \$10,244. All others are under \$10,000 with 17 counties having no township reward charges against the state.

THE REVOLT IN BRAZIL

When Don Pedro, Emperor of Brazil, was overthrown and a republic established it was accomplished not so much by the republicans as by a combination of rich slaveholding coffee planters of Sao Paulo and the leader of an aggreived military faction, General Deodoro da Fonseca. The coffee planters resented Don Pedro's decree emancipating the million and a half slaves without compensation to their owners. The militarists were alienated from him because of his pacifist leanings and his refusal to give army officers various privileges they demanded. Since that there has been constant friction between the government and the combination of militarists and coffee planters.

In 1922 when Herman Da Fonseca sought to return to political favor by backing Nilo Pecanha for the Presidency, the latter was overwhelmingly defeated by the liberal, Artur da Silva Bernardes. Then Da Fonseca organized the rebellion of 1922, which was crushed in two days. The present conflict is but a renewal of that attempt to seize the government. President Bernades has cut the army in size and has levied an income tax of 8 per cent on incomes over \$60:000. To prevent profiteering in foodstuffs the president took over the regulation of the handling of staple food supplies. For this he is denounced as a radical and the wealthy classes, with the aid of a few army officers, seek to seize the government by revolt.

At least one-third of the total population of 30,635,000 is of European blood. Between 1887 and 1917 1,-224,280 Italians were among the 2,897,804 immigrants who entered the country. Austro-Hungarians and Germans sent in a total of to to war if they wanted to. 150,000. These people seem to be content with the present government, and it is probable that peace will soon be restored in Brazil. The Administration of President Bernardes has appeared to justify itself in every way. He has the support of the best element in the country. Restoration of order would be welcome to the United States, if for no other reason than that the port of Santos is the outlet for many of the important raw products of which the United States is a large buyer.

WOMEN LAWYERS GROWNG PROFESSION

When a little group of 10 women lawyers met 25 years ago in the New York office of Miss Edith Griswold to form the Lawyers' Club the general legal standing of women admittedly was unequal. Not only were the pioneers within the profession making their fight for recognition but throughout the country women were struggling to be recognized as cognardians with their husbands of their children, to gain the right to sue and be sued, to make wills and to act as executors of wills.

Today sees a great advance for women both within the profession and without. There are still pioneers in various branches of legal profession, and there are still states where women have not gained equal guardianship and at 30. Nowdays, however, the tendency is to other laws. But compared with 25 years ago marry late rather than early in life, and the the legal rating of women has seen a great improvement.

No greater evidence of this tremendous advancement can be cited than by calling attention to the 480 brilliant women actually practicing as lawyers in the courts of the United woman of 35 and 40, and forgets her age. PROTEST AGAINST MOBILIZATION DAY

Charging that the proposed "Mobilization Day," on Sept. 12, would be a menace to peace and invite war, the Massachusetts Federation of Churches, has sent a letter of protest to the Secretary of war, John W. Weeks, with a petition to cancel all plans for the observation of such a day. The letter points out no possible technical advantages of mobilization day that can compensate for the loss of the moral pres. tige of the United States. "The more success. ful the demonstration of our power to mobilize, the more ground other nations will have to suspect and fear us," the letter says, and "For these reasons we earnestly petition you to canrel all such plans for a general mobilization lay." The petition asserts that the proposal of the American people of its peaceful purpose and intent, "especially at this time when the world sorely needs assurance of mutual confidence"— when no other nation on earth is financially able to maintain large armies or to

Science Explains Top Spinning. Everyone who has ever whirled a string to which a stone is tied must have noticed the strong "puil" as the stone tried to get away. Every part of a spinning top is trying to fly away from the center of the top in exactly the same way. This pull is called "centrifugal force"—the tendency to fly from the center. As each particle of the top has an equal pull, none of them can upset the balance of the others. So long as this force is strong enough—that is, so long as the spin asts- it counteracts the ordinary power of gravity, which has to confine itself to the peg of the top, the only point actually touching the earth. When the top slows down, the centrifugal force relaxes, gravity comes into its own again--and the top falls over. - Scientific American.

surpass any previously held.




