New Line Takes Over Entire Local Motor Passenger Service; Adds New Bus.

The Gray Bus Lines, whose motor passenger service between Niles and Buchanan City, via Buchanan and with Chicago electric rail connections, was instituted on April 1, have taken over the franchise to carry passengers between Niles and Buchanan from the Northern Indiana Railways, whose service will be discontinued June 26.

With the addition of the new service the Gray Bus Lines has installed a slightly revised time schedule and has added a new Yellow Coach parlor bus of the most modern type. Buses will leave the hotel Rex daily for Niles at 10:35 a. m., 3:35 p. m., and 7:35 p. m., with an extra trip at 8:35 a. m. week days. Buses will leave for Galien, Three Oaks, Michigan City and Chicago at 8:30 a. m., 12:20 p. m., and 5:05 p. m. daily, and an extra from Niles week days at 7:20 p. m.
