Now that a presidential campaign is in the making it may be seasonable to raise the old question of why it was that a town that has voted Republican since General John C. Fremont first headed up the party in 1854, not omitting even the time when Herbert Hoover headed it up in 1933, should be named after Democratic president.

Of course the straight of the matter is that the township of Buchanan was organized and named after James Buchanan some years before the town was platted in 1842. It was April 1, 1837,

that a message was brought to the cabin home of Dr. C. C. Wallin, located about a quarter of a mile from the mouth of McCoy's creek and about adjacent to the present L. B. Spafford home, notifying him that the new state of Michigan had authorized the organiza-tion of the township of Buchanan. The administration of Michigan was then Democratic. In fact the state remained Democratic until

the middle fifties when it lined up in the ranks of the new Republican party on the slavery issue. The state had named the new township after Buchanan, who was not to be president until another 20 years had passed.

The selection of the name was undoubtedly because of the gratitude that the state held for Buchanan, then congressman from Pennsylvania, because he had espoused the cause of the weak territory in its struggle for statehood and especially in the "Toledo War" with Ohio over the boundary between the two states.

On that occasion even the down right Andrew Jackson had "gone political" and sided with Ohio because the presidential election was impending and Ohio, with a 1,500,-000 people had more electoral votes than Michigan with 80,000. Jackson was much interested in seeing the election of his political heir, Martin VanBuren.

Consequently Jackson and his aides awarded the coveted strip on the south containing the site of the city in Todelo, to Ohio, attempting to appease Michigan by offering in compensation the upper peninsula, which was to be taken from Wisconsin which had practically no population at all and therefore no political influence. McCoy's Crick Along

By Harrison Merrill Your historian, the writer, as previously forecast now tackles that interesting chapter in the development-of Buchanan when the Silver Cornet band of the 90's was the leading social, if not musical, element along the ol' crick.

The writer tackles the subject with a certain degree of confessed modesty and with much trepidation. Be that understood!

To get at this latter intelligently-and that should be the purpose of all historians-one must create the atmospheric background that existed at the time to wit.

Since the beginning Buchanan had always been noted for its fine musical organizations. Always, after listening to remarks set forth by strangers within the gates Crick people were able to over-come all objections by saying, "Well, anyway, we've got a good band!"

But along in the early 90's interest in musical matters, so far as brass bands were concerned, was at an exceedingly low ebb. Most of the horn players had eithed passed on or had been deport-As a result the air, socially and musically, was stifling.

Hulda Hahn, Katie Deering and Ivah Henderson, instructors on the

piano-forte were struggling to keep interest in that instrument alive and with fair success and Dr. Dodd on Days avenue, was giving lessons in singing to certain young men who were planning a career with Hi Henry.

These women, their backs to the wall, struggled to keep B.ichanan on its feet musically and in doing so, carned the everlasting gratitude of many Crick people including the writer who took lessons from all four of said instructors

and who, therefore, owes what progress he has made at the keyboard and on the rostrum to such early instruction. People who study abroad-and

this is not said jestingly-no matter what progress they make, must, if fair, attribute their sucsuccess to the groundwork laid by those who first taught them their flats and sharps.

There were a few brass musicians within the village limits at the time but much professional jealousy existed and there was little chance of bringing them together. Mr. Charles "Pete" Fuller, who had been graduated, summa cum laude, from the Muskegon Heights Conservatory, on the valve trombone, was making personal ap-

pearances at various social functions but refused to mingle with

the lesser fry. Mr. Will Wood attending the La-Porte, Ind., School of Higher Watch Making also was majoring on the B-flat silver Courtoise cornet but on his frequent week-end visits to the village, refused to perform on that instrument outside of the Presbyterian church choir, where he served as the dispasor dianente for the new pipe organ.

Ed. Steele, John Graham and a number of other high class musical gentlemen, had hung up their instruments and Buchanan for the nonce, musically considered, was as dead as a door nail.
