On February 6 Bouchon was summoned to a cafe in the Rue Royale to give aid to the injured. He remained at the disposition of Bonnefoy-Sibour, who was prefect.of the Seine at the time, from 7:30 until after midnight. As he was leaving the cafe he was drawn into a crowd of rioters and was swent on with them to the Place de la Concorde. In the fighting that ensued Bouchon was injured serious-

Unable to continue in the medical profession, as he has been confined to a hospital since he was injured, Bouchon has engaged a lawyer to get financial recompense.
