MRS. W. R. ROUGH

Mrs. W. R. Rough Tells of Days As **Bride in Log Cabin at New Troy**

Celebrates 90th Birthday at the sawmin. Her Home Here Sunday

Sunday was an important day at the home of Mrs. W. R. Rough and her daughter and husband, Mr. and Mrs. J. C. Rehm, marking the 90th birthday of Mrs. Rough and the 37th wedding anniversary of the Rehms.

A turkey dinner honored the occasion, guests being Mrs. Susan Lyddick and Mr. and Mrs. Guy Young and Mrs. Sylvia Rhoades and daughter, Ruth and son, Carl, Kalamazoo. Mrs. Rhoades was formerly a resident of the Bend of the River and of Portage Prairie, and was a girlhood friend of Mrs. Rehm, acting as bridesmaid at the Rehm wedding.

Mrs. Rough reaches her ninetieth milestone in quite good health and with a more than ordinary memory for the times and the customs of the days when she first came to Michigan, a German girl, from Millheim, Penn., bound for the home of friends at the German settlement now called Hinchman.

She had made the trip west to Elkhart in 1869, in company with a party of 43. At Elkhart she took the stage to Niles, arriving there in the daytime and waiting until night for the stage to Berrien Springs, where her friends

There she worked at the old Feathers homestead enjoying the substantial and pleasant life of the well-to-do Germans. In Michigan she learned first the delights of orchard peaches, and the process of canning them. Back in the Pennsylvania German settlements they had dried everything, even slicing the tomatoes and drying them. During her first year in Michi-

gan she became acquainted with Levi Nelson Barnhart and in the fall of 1869 she married him and moved to a one-room log cabin on the Barnhart farm a mile and a half south of New Troy. Their cabin was but a few feet from the larger home where her parents-in-law lived, and it was the first house on the Barnhart farm. The logs had been hewed, and the cracks were chinked with wood and mortar and the structure whitewashed on the inside. neavy boards, an inch and a half thick, were used for the roof, the cracks running up and down, and were covered with the "slaps" of the logs. They had two beds curtained off at the side of the room.

There she lived with her husband, helping him saw the trees into logs which were delivered at the Avery sawmill almost direct-Central railway. One of the most vivid memor ies Mrs. Rough carries down from those days was the condition of the roads. The settlers in the woods chopped a space clear for groad, building sections of "corduroy" for miles across the swamps. This road was built by laying small logs, perhaps 6 inches through, side by side. The men of the district would work under the highway man or "pathmaster" digging ditches along the sides of the corduroy and throwing brush and dirt on top.

After a while, when their cirumstances had improved, they hauled logs to Avery's mill and brought back the sawed lumber. building a frame house for themselves. This was one of the great occasions of pioneer life moving out of the log house into the "big house," and Mrs. Rough remembers it all.

Barnhart worked year after year clearing his 180 acre farm, hauling logs to the Avery mill, or perhaps sawing the smaller trees and selling it at from \$1 to \$2 per cord, either at Avery or at the Brownstown pier, near where Sawyer now is, to be shipped to Chicago. For years the Michigan woods kept Chicago warm.

One year in the early seventies the Michigan woods came near making everybody warm. In the dry fall when the Chicago fire happened, in October 1873, the whole west coast of Lake Michigan was also swept by fires that kept springing up in the tinder dry woods. Mrs. Rough remembers that the men came from far and near with their plows and other implements to stop the flames, which came within a half mile of the Barnhart farm. She stood on the porch of her home and listened to the sound of the giant trees crashing in the

Other times she stood in the pack door of their cabin and saw the wild deer feeding in the clear

Mrs. Rough told of the celebrations of July 4th. Men and boys would rise early and fire salutes. Then a common mode of observance would be to go through the woods to the Brownstown pier and there fish off the pier all Mr. Barnhart died Sept. 3, 1883

and later she was married to W. R. Rough, on Dec. 8, 1892 moving to the home where she now lives in Buchanan.

There is a marked improvement in grades at school each year when the serving of milk is started. Let us give that needed nourishment to all of the children. Our local dairies have taken turns in providing this milk to the schools, each year the dairy giving it at cost. It is a great deal of extra labor to bottle all the milk in half pints and then wash the bottles and handle them. We, as a P. T. A. Organization, feel very grateful to the local dairies and we wish to thank them along with all who are helping us to give milk to

A PROPER SURFACE FOR THE REDBUD TRAIL

Now during the winter traffic lull it is a good time to specu-late what is to be done about a good summer surface for the Red-

State highway department landscape specialists have stated that the state has nothing this side of the Upper Peninsula to compare with the beautiful river road north of Buchanan. A Chicago woman called on a Buchanan resident who was a patient recently in a Chicago hospital.

"I stopped at your place last week," she said, "We were driving southeast out of St. Joseph when we saw a side road that said

ing southeast out of St. Joseph when we saw a side road that said 'To Buchanan'. I remembered that you lived there so we turned off and went over the most beautiful winding road along the river. It was just a lucky accident, for I had never heard of it."

That was the impression gleaned from a chance acquaintance with the Trail. But the road is well known among Michigan residents, yet it is fair to say that it carries only a fraction of the summer traffic it would otherwise receive on account of the clouds of dust that rise from the gravel surface in dry summers. During the drouth last summer the dust became so heavy that the effactually screened all the scenery, and created a traffic hazard it addition, practically decimating the potential traffic.

The question arises why the present surface might not be treated with oil. In the Rocky mountain section, where the blackasphart is available at low prices, there are thousands of miles of oil-treated gravel that are smooth, fast roads, inferior in no way to other surfaces. This treatment would be especially fitting for the Red Bud trail from the fact that it is not as slippery in icy weather as concrete or asphalt retread.
